2. This Contract is awarded in accordance with the Fair and Open Process

procedures pursuant to the provisions of N.J.S.A. 19:44-20.4.

3. A notice of Contract Award shall be published in the Atlantic County Record and

in the Daily Journal as required by law within ten (10) days of its passage.

4. The Solicitor's Professional Services Agreement, as well as a copy of this

Resolution, shall be maintained on file in the Office of the Secretary of the

Authority, where such documents shall be available for public inspection during

normal business hours.
