WHEREAS, it is necessary and proper that the Authority confirm all action taken by its Engineer, in the publication of the specifications seeking bids; and

WHEREAS, upon proper application, bids were received, opened and read on October 9, 2020 at 11:00 a.m. by the Authority at the Borough of Buena Municipal Building located at Central Avenue in Minotola, New Jersey; and

WHEREAS, MBE Mark III Electric, Inc., having its principal place of business at 213 Main Street, Madison, New Jersey, 07940, submitted the lowest responsible bid in the amount of \$1,188,378.00 for the rehabilitation of Pump Stations #1, 2 & 3 and grit system; and

WHEREAS, the Authority’s Engineer, Remington & Vernick Engineers has recommended that the Authority accept the lowest responsible bid submitted by MBE Mark III Electric, Inc.; and

WHEREAS, the Treasurer of the Authority has certified the availability of funds for a contract to be awarded to the lowest responsible bidder.

NOW, THEREFORE, BE IT RESOLVED that all action taken by the Authority’s Engineer, Remington & Vernick Engineers, in publishing specifications for bids and the

subsequent action taken by the Authority, in respect to its acceptance of the lowest responsible bid for the published services, be and these actions are hereby confirmed and approved.

BE IT FURTHER RESOLVED that the Secretary of the Authority is hereby authorized to return all bids, certified checks and/or bid bonds to any and all rejected bidders.

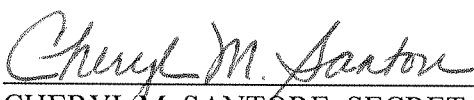

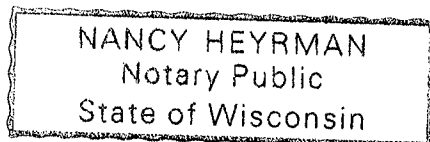

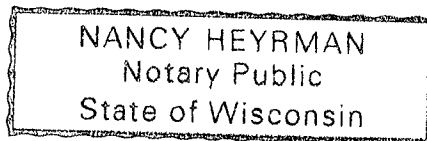
