WHEREAS, the Authority's Engineer, Remington, Vernick & Walberg has recommended that the Authority accept the lowest responsible bid as submitted by Rio Supply, Inc.; and

**WHEREAS**, the Treasurer of the Authority has certified the availability of funds for a contract to be awarded to the lowest responsible bidder.

NOW, THEREFORE, BE IT RESOLVED that all action taken by the Authority's Engineer, Remington, Vernick & Walberg, in publishing specifications for bids and the

subsequent action taken by the Authority, in respect to its acceptance of the lowest responsible bid for the published services, be and these actions are hereby confirmed and approved.

**BE IT FURTHER RESOLVED** that the proper officers of the Authority be and the y are hereby authorized to execute any and all documents required with respect to the awarding of a contract for the furnishing and delivery of water meters to Rio Supply, Inc.

Dear Chairman and Board Members:

Bids were received for the referenced project on December 16, 2020. One bid was received from RIO Supply, Inc., 100 Allied Parkway, Sicklerville, New Jersey 08081 in the amount of \$44,100.00. The bid was based upon furnishing and delivery of 100 3/4" X 3/4" water meters and 25 1" water meters.

The unit price for the  $\frac{3}{4}$ " X  $\frac{3}{4}$ " meters was \$333.00 and the unit price for the 1" meters was \$432.00. It should be noted that the bid prices for the water meters are the same as the existing contract.

Therefore, in accordance with the Local Public Contracts Law, NJSA 40A:11-1 et seq., the contract should be awarded to the lowest responsible bidder, which appears to be RIO Supply, Inc. with a bid in the amount of \$44,100.00. The award should be contingent upon approval of the MUA Solicitor and funds being available.

Based upon our review of the bid, we noted the following:

- The Bid Bond listed the owner as Borough of Buena, not the Buena Borough Municipal Utilities Authority.
- The Consent of Surety listed Borough of Buena as the contracting agency, not Buena Borough Municipal Utilities Authority.
- The bidder did not provide his DUNS Code on the Certification of Non-Debarment for Federal Government Contracts Form. However, we obtained the DUNS Code from Rio Supply and verified that they have no active exclusions.

The above issues are deferred to the Board Solicitor for review.

By copy of this letter, I am e-mailing a copy of the bid to the Board Solicitor for review. If Mr. Testa or Mr. Casella need to see originals of any documents, I would request that they contact my office.
