

Bids were received for the referenced project on December 16, 2020. One bid was received from Falasca Mechanical, Inc., 3329 N. Mill Road, Vineland, NJ 08360. A copy of the tabulation is enclosed for your review.

The rates bid by Falasca Mechanical, Inc. are equal to or less than the rates from the current contract. Falasca Mechanical, Inc. is the current contractor.

Therefore, in accordance with the Local Public Contracts Law, NJSA 40A:11-1 et seq., the contract should be awarded to the lowest responsible bidder, which appears to be Falasca Mechanical, Inc. The award should be contingent upon approval of the MUA Solicitor and funds being available.

The MUA must now determine whether to award a contract for a one (1) year term or a two (2) year term. The hourly rates are the same for the Base Bid (one year term) and Alternate Bid (two year term).

Based upon our review of the bid, we note the following:
