RESOLUTION AWARDING CONTRACT FOR  
PROFESSIONAL SERVICES PURSUANT TO THE  
FAIR AND OPEN PROCESS TO REMINGTON & VERNICK FOR  
ENGINEERING SERVICES

**WHEREAS**, pursuant to the Fair and Open Process on January 6, 2021, the Borough of Buena Municipal Utilities Authority (hereinafter referred to as the “BBMUA”) received, publicly opened, and read qualifications submitted in response to a Request for Qualifications for Professional Engineering Services; and

**WHEREAS**, the BBMUA authorizes the Chairman and the Secretary of the BBMUA to retain the Professional Services of Consulting Engineers in accordance with the Fair and Open Process.

**WHEREAS**, three (1) firm, Remington & Vernick Engineers, 845 North Main Street, Pleasantville, New Jersey 08232, submitted qualifications in response to the Request for Qualifications; and

**WHEREAS**, the qualifications submitted were evaluated in accordance with the criteria set forth; and

**WHEREAS**, it was determined that the qualifications submitted by Remington & Vernick Engineers met the submission requirements; and

**WHEREAS**, funds are available for this purpose.

**NOW, THEREFORE, BE IT RESOLVED BY THE BBMUA** as follows:

1. The Chairman of the BBMUA is hereby authorized and directed to execute the agreement filed with the Secretary and with Remington & Vernick Engineers to supply engineering services for the period of February 1, 2021 through January 31, 2022 in an amount not to exceed a yearly total of \$75,000.00 in accordance

with the schedule of billable hourly rates attached to the Professional Services Agreement.

2. This Contract is awarded in accordance with the Fair and Open Process procedures pursuant to the provisions of N.J.S.A. 19:44-20.4.
3. A notice of Contract Award shall be published in the Atlantic County Record and in the Daily Journal as required by law within ten (10) days of its passage.
4. The Engineer's Professional Services Agreement, as well as a copy of this Resolution, shall be maintained on file in the Office of the Secretary of the Authority, where such documents shall be available for public inspection during normal business hours.

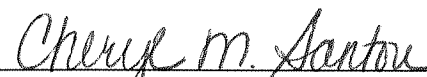

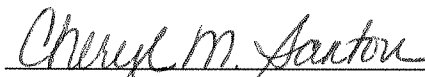
