**NOW, THEREFORE, BE IT RESOLVED BY THE BBMUA** as follows:

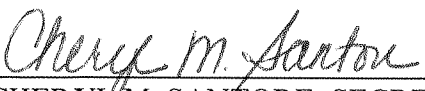
