NOW, THEREFORE, BE IT RESOLVED BY THE BBMUA as follows:

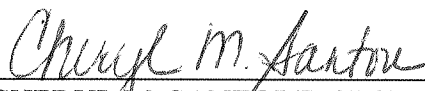

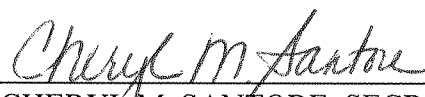

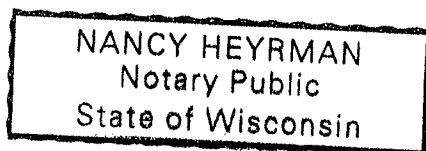
