RESOLUTION AUTHORIZING THE BOROUGH OF BUENA MUNICIPAL UTILITIES
AUTHORITY TO CEASE BILLING THE BOROUGH OF BUENA FOR TWO PROPERTIES
RECENTLY ACQUIRED BY THE BOROUGH OF BUENA TO COINCIDE
WITH THE CURRENT UNDERSTANDING BETWEEN THE BOROUGH OF BUENA AND
THE BOROUGH OF BUENA MUNICIPAL UTILITIES AUTHORITY

WHEREAS, the Borough of Buena Municipal Utilities Authority and the Borough of Buena agreed in 1984 to house the Office of the Borough of Buena Municipal Utilities Authority in the Municipal Building of the Borough of Buena as a convenience to the ratepayers serviced by the Authority; and

WHEREAS, in lieu of rent being paid to the Borough of Buena for the office space it was agreed that the properties owned by the Borough of Buena would not be billed for sewer and or water services; and

WHEREAS, the Borough of Buena took ownership of the building located at 200 Arbor Avenue, Landisville, New Jersey 08326, having a Block of 136 Lot 4 previously owned by Landisville Fire Company as well as the building located at 255 Wheat Road, Vineland, New Jersey, 08360, having a Block of 207 Lot 59 previously owned by the Buena Boro Fire District 2 Board of Fire Commissioners; and

WHEREAS, the Board of the Borough of Buena Municipal Utilities Authority agreed at the regular meeting held on October 25, 2023 that any outstanding bills owed on both properties be paid in full effective immediately and beginning November 1, 2023 no further billing will be charged for either building listed in this resolution however, water will still continue to be metered and said meters will continue to be read each quarter for State reporting purposes.

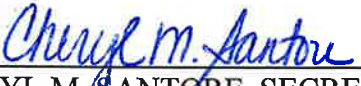

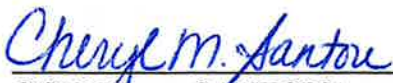
