RESOLUTION AWARDING CONTRACT TO HUGHES ELECTRIC CO., LLC
FOR THE PURCHASE OF THE WELL #3 EMERGENCY GENERATOR
IN THE AMOUNT OF \$355,370.00

WHEREAS, the Borough of Buena Municipal Utilities Authority (hereafter "Authority") has arranged for the publication of specification and terms for an emergency generator and well #3; and

WHEREAS, the Authority's Engineer, Remington & Vernick Engineers, as required by law, caused to be published specifications for the bidding for such work in accordance with the relevant New Jersey Statute prescribing publication in such matters; and

WHEREAS, it is necessary and proper that the Authority confirm all action taken by its Engineer, in the publication of the specifications seeking bids; and

WHEREAS, upon proper application, bids were received, opened and read on August 20, 2024 at 11:00 a.m. by the Authority at the Borough of Buena Municipal Building located at Central Avenue in Minotola, New Jersey; and

WHEREAS, Hughes Electric Co., LLC, having its principal place of business at 40 Old Turnpike #1, Pleasantville, New Jersey, 08232, submitted the lowest responsible bid in the amount of \$355,370.00 for the installation of an emergency generator at Well #3; and

WHEREAS, the Authority's Engineer, Remington & Vernick Engineers has recommended that the Authority accept the lowest responsible bid submitted by Hughes Electric Co., LLC; and

WHEREAS, the Treasurer of the Authority has certified the availability of funds for a contract to be awarded to the lowest responsible bidder.

NOW, THEREFORE, BE IT RESOLVED that all action taken by the Authority's Engineer, Remington & Vernick Engineers, in publishing specifications for bids and the

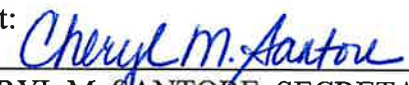
subsequent action taken by the Authority, in respect to its acceptance of the lowest responsible bid for the published services, be and these actions are hereby confirmed and approved.

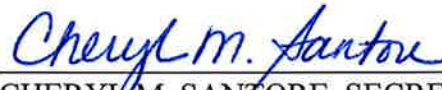
