RESOLUTION AWARDING CONTRACT FOR
PROFESSIONAL SERVICES PURSUANT TO THE
FAIR AND OPEN PROCESS TO ROMANO, HEARING, TESTA & KNORR FOR
AUDITING SERVICES

WHEREAS, pursuant to the Fair and Open Process on January 18, 2024, the Borough of Buena Municipal Utilities Authority (hereinafter referred to as the “BBMUA”) received, publicly opened, and read qualifications submitted in response to a Request for Qualifications for Professional Auditing Services; and

WHEREAS, the BBMUA authorizes the Chairman and the Secretary of the BBMUA to retain the Professional Services of Auditors in accordance with the Fair and Open Process.

WHEREAS, one (1) firm, Romano, Hearing, Testa & Knorr, Certified Public Accountants, 1830 Gallagher Drive, Suite 104, Vineland, New Jersey 08360-1557, submitted qualifications in response to the Request for Qualifications; and

WHEREAS, the qualifications submitted were evaluated in accordance with the criteria set forth; and

WHEREAS, it was determined that the qualifications submitted by Romano, Hearing, Testa & Knorr met the submission requirements; and

WHEREAS, funds are available for this purpose.

NOW, THEREFORE, BE IT RESOLVED BY THE BBMUA as follows:

1. The Chairman of the BBMUA is hereby authorized and directed to execute the agreement filed with the Secretary and with Romano, Hearing, Testa & Knorr to supply auditing services for the period of February 1, 2024 through January 31, 2025 in accordance with the schedule of hourly rates as submitted in the RFQ with the total yearly amount not to exceed \$64,000.00.

2. This Contract is awarded in accordance with the Fair and Open Process procedures pursuant to the provisions of N.J.S.A. 19:44-20.4.
3. A notice of Contract Award shall be published in the Atlantic County Record and in the Daily Journal as required by law within ten (10) days of its passage.
4. The Auditor's Professional Services Agreement, as well as a copy of this Resolution, shall be maintained on file in the Office of the Secretary of the Authority, where such documents shall be available for public inspection during normal business hours.

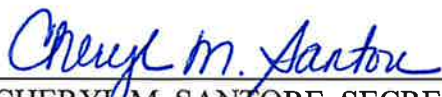
