**** Reconnected Tapping Fees – Payment of (1/2) of the current tap-in fee in effect at the time of connection, provided the reconnection takes place within (5) years from the date of disconnection; thereafter the full tap-in fee in effect at the time of connection will be required. (Resolution R-48-93).**
