**TOWN OF KEYSTONE
SNOWMOBILE ORDINANCE**

(Amendment to previously proposed & adopted Ordinance Adopted March 6, 1973)

**THE TOWN OF KEYSTONE, BAYFIELD COUNTY, WISCONSIN, DOES
HEREBY ORDAIN AS FOLLOWS:**

1. All Town Roads in the Town of Keystone shall be open to snowmobiles and other vehicular traffic except as posted otherwise.
2. The intent of this Ordinance is to establish routes within the Town of Keystone whereby Snowmobiles may reach the trails and routes located outside the Town of Keystone. It is not intended that this Ordinance establish our town roads for the purpose other than leaving or entering the town.
3. All above traffic shall be on the right side of the road, which is with the flow of general traffic such as automobiles, etc..
4. Snowmobiles shall not exceed 30 miles per hour while operating on town roads within the limits of the Town of Keystone.
5. All above traffic shall be in single file and always with at least one headlamp lit.
6. At intersections, all Snowmobile traffic shall stop and yield to automobile traffic and observe all other traffic laws.
7. There shall be no trespassing on private lands without the owner's permission.
8. There shall be no racing or maneuvering, speed shall be consistent with the road conditions at all times.

9. There shall be no Snowmobiling on tree plantations.

10. There shall be no unnecessary noise when near human habitat.

11. The Town of Keystone shall not be liable or responsible for any action, suit, or claim of any nature resulting from the operation of Snowmobiles on any Town Roads or Town Property pursuant to this Ordinance and the owner operator of any Snowmobile so operated on said property shall hold the said, TOWN OF KEYSTONE HARMLESS AND WITHOUT LIABILITY on the part of any claimant for death, injury to person or property on said Town Roads or Town Property, as aforesaid, as a result of the ownership or operation of Snowmobiles thereon.

12. No Snowmobile shall be operated on any Town Road or Town Property in places permitted by said Ordinance unless the owner and operator of each Snowmobile so operated shall be covered by a policy of liability insurance for the protection of persons and property in the same amounts and with the same requirements as required under the Motor Vehicle Financial; Responsibility Statute, insofar as said conditions and provisions may be applicable to Snowmobile vehicles.

The right to operate motor vehicles on Town Roads and Town Property, pursuant to the aforesaid Ordinance, shall be conditional upon compliance with the previously mentioned requirements relating to insurance coverage.

The foregoing Ordinance was adopted at a Town Board Meeting on the ninth day of January, 1971; and amended by said Town Board on the sixth day of March, 1973.
