



Special Town Meeting Minutes 12.16.2025 ~~ Town of Whitefield

Yolanda Opened the meeting at 5:47 pm by Welcoming those who came out this evening then proceeded to read the greeting...

GREETINGS,

In the name of the State of Maine, you are hereby required to notify and warn the residents of the Town of Whitefield, Maine in Lincoln County, qualified to vote on Town affairs, to assemble at the **Whitefield Central Fire Station** located at 24 Townhouse Road in said Town of Whitefield on **Tuesday, December 16, 2025 at 5:45 PM**, then and there to act on Articles 1 through 2 as set out below, to wit:

Article 1: To elect a **Moderator** by written ballot to preside at said meeting.

Glenn Angell was nominated to serve as Moderator, with no other nominations, it was moved and seconded, with No discussion,
Then went to vote by paper ballot by voters that were present. 5-0 voted for Glenn Angell

***Article 1: The Town voted to elect Glenn Angell as Moderator to preside at said meeting.**

The town clerk, Yolanda Violette, administered the Oath of office to the moderator, Glenn Angell.

Glenn presented that we would be following the 2021 7th edition Moderators Manual.

Article 2: Shall the Town of Whitefield vote to approve a Community Development Block Grant project development for the following program(s) and dollar amounts: Program: Community Development Block Grant Economic Development Program in the amount thirty thousand dollars (\$30,000); and to submit same to the Department of Economic and Community Development and if said program is approved, to authorize the municipal officers to accept said grant funds, to make such assurances, assume such responsibilities, and exercise such authority as are necessary and reasonable to implement such programs. Furthermore, the Town of Whitefield is cognizant of the requirement that should the intended National Objective of the CDBG program not be met all CDBG funds must be repaid to the State of Maine CDBG program.

The article was moved as written and seconded,

With No discussion,

Went to vote by show of hands, majority in favor, Motion passes as written.

Article 2: The Town voted to approve a **Community Development Block Grant** project development for the following program(s) and dollar amounts: Program: **Community Development Block Grant Economic Development Program** in the
