FROM THE TOWN BOARD

The Town Board continues to explore ways to keep your taxes low while provide the same level of service to residents, in a more efficient and cost-effective manner.

In 2012, the Town has contracted with private contractors to perform summer road maintenance projects, such as chip sealing, crack filling and ditch-mowing. Garbage and Recycling expenses for 2012 are almost \$17,000 less than was spent in 2011.

The Town Board is currently exploring the possibility of contracting the winter snowplowing responsibilities to a private contractor. In recent years, the snowplowing expense has risen, as well as the number of complaints. In a time of no-increase tax levies, the Town Board feels it must be responsible to the taxpayers by at least requesting bids from outside sources, for comparison.

The Highland Bridge over the Interurban Bike Trail is in need of repairs, replacement, or complete removal. A quote for removal is currently being prepared by an engineer. It is expected that removal of the bridge will be the least expensive option in the long-run, and increase safety for all whose drive this stretch of Highland.

There are also a number of other road projects being explored for the next few years. Birch Road, Birch Lane, Northwoods Road, Towhee Trail and Norport Road are all in need of some repair. A re-construction and widening of Green Bay Road, to improve safety, is also being considered for the near future.

FROM THE PLAN COMMISSION

Amendments to the acreage requirements of the Agriculture-zoned districts is currently being reviewed by the Plan Commission and Town Planner.

Work continues on attracting new business to the Knellsville area, with possible amendments to the strict standards on new development.

Plan Commission Meetings are the second Wednesday of each month at the Town Hall.

GARBAGE & RECYCLING - Updates

A year has passed since changes came to the Town of Port residents in how their garbage and recycling is handled. Recent site improvements include fencing, paving and a camera system to identify after-hours dumpers.

DROP-OFF HOURS ARE:

THURSDAYS: 4:00PM – 6:00PM SATURDAYS: 8:00AM – NOON

To improve traffic flow, we require all cars to enter from Highland Drive, on the south side of the building. This allows for a drive-thru flow of traffic, to eliminate congestion.

Please pull to the side if you plan to socialize, so as to accommodate your neighbors in a hurry.

You may continue to use the 2011 residency card to prove your residency, when necessary. You may also provide a drivers license with your current Town of Port Washington address. Our attendant tends to recognize most Town of Port Washington residents, but it's a good idea to have the card with you, if necessary.

These changes have saved you tax money. In 2011 the total cost for garbage and recycling was \$ 52,382 . For 2012 the total cost for garbage and recycling, including site improvements and employee wages is \$ 35,469 . Though cost-savings was not the sole purpose for the new site, it appears to be a definite result.

If you have any comments or ideas on how the process could be improved, please share them with the Town Board. The Town Board meetings are held the first Monday of each month at 7:30 PM at the Town Hall.

FROM THE TREASURER'S DESK

2013 REAL ESTATE & PERSONAL PROPERTY TAX PAYMENTS

BY MAIL: Include a tear-off stub with your check made out to Town of Port Washington-Treasurer, and mail to:

DO NOT mail back the actual bill.

LOCAL BANK: You may make payments during lobby hours at:

<u>PWSB</u>– <u>Port branch</u> OR <u>Harris Bank- Port branch</u>. If you have a refund coming, payment at the banks is suggested. Refunds can only be made after the entire tax bill has been paid.
