# FROM THE TOWN BOARD

- The Town of Port Washington is under contract with Dave's Excavation & Grading for snow removal on Town Roads for 2014-2016. The general consensus of residents is that the roads are being cleared in a timely manner, and for an equivalent amount of money. Sand will be mixed with salt this year due to skyrocketing salt prices.
- Jim's Maintenance is under contract to perform ditch-mowing in 2015. This occurs twice/year in rural areas.
- Lone Wolf Tree Service performs Tree Removal and trimming at the request of the Town Board.

- The Highland Drive Bridge over the Interurban Bike Trail is expected to be removed in the Summer of 2015. The bridge is in poor condition and lowering the road will increase safety for all who drive this stretch of road. Public input will be sought at a December 1st informational meeting at 6:00pm at the Town Hall.
- There are also a number of other road projects being explored for the next 2-4 years. Green Bay Road between Hwy LL & Hwy 33 will receive an overlay of asphalt, and will be striped with center and edge lines, in an effort to slow traffic down. Northwoods Road will also require an overlay of asphalt. This road creates confusion in that it is a multi-jurisdictional road between the Village of Saukville, Town of Saukville & Town of Port Washington. The road is divided into sections, rather than split down the center of the road, and an agreement is on file as to which municipality is responsible for maintenance and repairs of each portion. Ideally, the 3 municipalities would like to resurface at the same time, but budgets may not allow this to happen. Towhee Trail, Dynna Drive and Norport Drive are also in need of some repair over the next few years.
- Town Board Meetings are the first Monday of each month at the Town Hall. See the schedule below for upcoming meeting dates.

## FROM THE PLAN COMMISSION

- The Plan Commission is currently reviewing road standards as they relate to implements of husbandry. These standards regulate the weight and classification of farm equipment allowed to operate on Town Roads, and the Town's recourse should the road be damaged.

The Drop-Off Site will be CLOSED on the Thursday of these two weeks.


- Please respect the hours as posted. The Attendant needs time to close and open the site, and coming early and late does make his job a little difficult.
- All garbage must be bagged.
- To improve traffic flow, we require all cars to enter from Highland Drive, on the south side of the building.

  This allows for a drive-thru flow of traffic, to eliminate congestion.
- Please pull to the side if you plan to socialize, so as to accommodate your neighbors in a hurry.
- You may continue to use your current residency card to prove residency, when necessary. You may also provide a drivers license with your current Town of Port Washington address. Our attendant tends to recognize most Town of Port Washington residents, but it's a good idea to have the card with you, if necessary.

### ANNEXATION OF TOWN LAND

What does the Town of Mequon (Ozaukee County), Town of Lake (Milwaukee), and Town of Preble (Brown County) all have in common? They no longer exist! A town's boundaries can change via annexation, incorporation or consolidation. Since Wisconsin became a state in 1848, the factors noted above have severely eroded the boundaries of towns all across the state from their original six-mile-by-six-mile template, as each was originally set up with via the Public Land Survey System of 1787. Annexation tends to generate the most widespread publicity and is the most common way for a town's geographic boundary shrink.

#### WHAT IS ANNEXATION?

Generally speaking, "annexation" is the process used by cities and villages to increase their size through the acquisition of additional land from a town. In most cases, the land which the city or village seeks to acquire needs to be contiguous to the city's or village's existing boundaries. The Town of Port Washington shares boundary lines with the Village of Saukville and the City of Port Washington.

#### WHY DO VILLAGES AND CITIES ANNEX LAND?

The most common reason is to raise the tax base. Property taxes are the primary source of revenue for local governments. As such, cities and villages have a strong financial incentive to expand their boundaries so they will have a greater bonding capacity due to increased valuation. Also, size and population and will enhance its ability to attract desirable commercial development. Since the year 2000 the City of Port Washington annexed approximately 500 acres of land from the Town.

#### HOW DOES A CITY/ VILLAGE OR LAND OWNER ANNEX LAND?

As outlined in Wis. Stat. § 66.021, there are three common methods that can be used to annex town lands: direct annexation, annexation by referendum, and annexation of certain town islands. Most commonly the process is triggered by a landowner or developer who wants to either connect to municipal sewer or develop the land at a higher density than permitted by the town. This would be an example of direct annexation, where the land owner/owners of the property sign a petition. Then procedural notices are completed including a review by The Wisconsin Dept. of Administration (DOA). Finally the city or village needs a two-thirds vote to adopt the annexation through an ordinance. A town can do little to stop or prevent annexations of town land unless it can be determined to be "not in the public's interest".

#### **DISADVANTAGES OF ANNEXATION FOR A TOWN:**

When cities/villages have authority to annex town land with such ease, it makes it difficult for a town to plan for the future. Many towns are unwilling to engage in planning or provide services for their residents, fearing that an annexation will undermine these efforts. Also, towns, like cities and villages, rely on property taxes as their principal source of revenue. Therefore, when a city or village annexes town land, a portion of the town's tax base is eliminated. Because of this, towns across the state, including the Town of Port Washington, have in the past found themselves engaged in bitter and costly lawsuits with their municipal neighbors over boundary disputes.

#### **SOLUTIONS**

In 2004 the Town of Port Washington entered into an agreement with the City of Port Washington that provides for orderly land development. This agreement addresses a wide range of infrastructure, land use, service and finance plans. In addition, the agreement sets and delineates a boundary agreement set until the year 2025. This agreement gives the town (and city) the ability to plan for the future without the fear of litigation.

# **Dog Licenses**

#### Mary Sampont, Town Treasurer

All dogs over the age of 5 months must be licensed, per WI State Statute 174.05. Please complete and return this dog license application to the Town Treasurer with the appropriate fee, and a copy of the current rabies certificate.

All Dog License Applications are due April 1st each year, or within 2 weeks of acquiring a new dog.

- All dogs must be licensed in the Town of Port Washington. Unlicensed dogs could result in a fine for the owner if found by the Sheriff Dept or Humane Society. Licensing also helps locate the owner if the dog runs away.
- If you own a dog/s, please complete the application below and send it along with your tax payment.
- At this time Dog Licenses cannot be accepted at the banks, but must be sent to the Town Treasurer.
- Please do not include the dog license fees on the same check as your property tax payment.
- You will need to send along verification of rabies vaccination.

Please send a self-addressed, stamped envelope along for your return dog tag, license and any vaccination records sent.
