RE: Natural Feature Analysis on Keeney Estates Subdivision

To whom it may concern,

Attached below is the Natural Feature Analysis report for the Keeney Estates Subdivision, located at 418 E. 51st Street, Garden City, ID. This comprehensive report provides an in-depth assessment of the site's natural features, including topography, vegetation, water resources, and wildlife habitats. It is essential for understanding the environmental context of the property and ensuring that our development plans are environmentally responsible and compliant with local regulations.

Hydrology:

The existing drainage on-site currently sheet-flows towards the southeast corner of the property or infiltrates into the ground, depending on soil percolation capabilities. It is unclear whether the drainage from the site is collected and channeled through the storm drain inlet located near the southeast corner of the property on E. 51st Street. However, it is assumed that runoff from the existing sidewalk and driveway entrance is captured by this storm drain inlet.

Soils:

Soils information is based on data from the United States Department of Agriculture (USDA) Natural Resources Conservation Service (NRCS) Web Soil Survey for Ada County. The soils identified within the property are listed in the table below.

A soil complex consists of two or more soils arranged in such an intricate pattern or in such small areas that they cannot be shown separately on a map. For this area, a typical soil profile includes:

- ❖ 0 to 35 inches: Fine sandy loam
- ❖ 35 to 70 inches: Stratified extremely gravelly coarse sand to very gravelly loamy sand.

Topography:

Elevations for the site are based on the North American Vertical Datum of 1988 (NAVD 88). Contours are displayed at 1-foot intervals, providing a detailed and precise representation of the site's topography. A general comprehensive site assessment of the subject property has identified no areas of shallow bedrock, unstable rock formations, landslides, poorly

graded areas, or artificial fill. Additionally, there are no detected unstable or unsuitable soils for development, ensuring the site is appropriate for construction purposes. The topography of the site is relatively flat with a gentle slope (~ 1.0% slope), directing natural drainage towards the southeast corner of the property.

Vegetation:

The existing vegetation on the site includes a variety of plant species contributing to the area's ecological diversity. Notable features include:

- ❖ Evergreen trees are located in the southern portion of the site as well as the northern portion. The evergreen trees located at the southeast corner of the site are smaller in comparison to the northwest corner.
- ❖ Cool weathered lawn area (combination of bluegrass, ryegrass, and fescues).
- ❖ Patches of native grasses and shrubs, particularly prominent in the vacant lot towards the northern half of the site.
- ❖ Additional mature trees are located on the vacant lot in the northern portion of the site (based on provided imagery, the mature trees on site resemble Burch or Cottonwood)

Sensitive Plant and Wildlife Species:

According to the Information for Planning and Consultation (IPaC) resource list provided by the U.S. Fish & Wildlife Service, there are no sensitive plant or wildlife species present on the site. The IPaC report indicates that the area does not support any federally listed threatened or endangered species, nor does it contain any critical habitats that require conservation measures.

For a comprehensive overview of the findings and any additional considerations, please refer to the attached IPaC report.

Historic Resources:

There are no identified historic resources on the subject property. The nearest historical resources are located at W. State Street and N. Plantation River Drive (Pedro Echevarria House) and Spaulding Ranch near the intersection of N. Cole Road and N. Mountain View Drive.

Hazardous Areas:

None Identified.

Impact on Natural Features:

The proposed use of the site is not anticipated to have any significant impact on the existing natural features. The current project plan preserves the integrity of the surrounding ecosystems. The design incorporates measures to protect the natural landscape, including the conservation of native vegetation and the implementation of erosion control strategies.

Additionally, no critical habitats or sensitive species have been identified within the project area, reducing the likelihood of adverse ecological effects. Best management practices will be employed during construction to minimize disturbances to the soil and water resources, ensuring the protection of local wildlife and plant life.

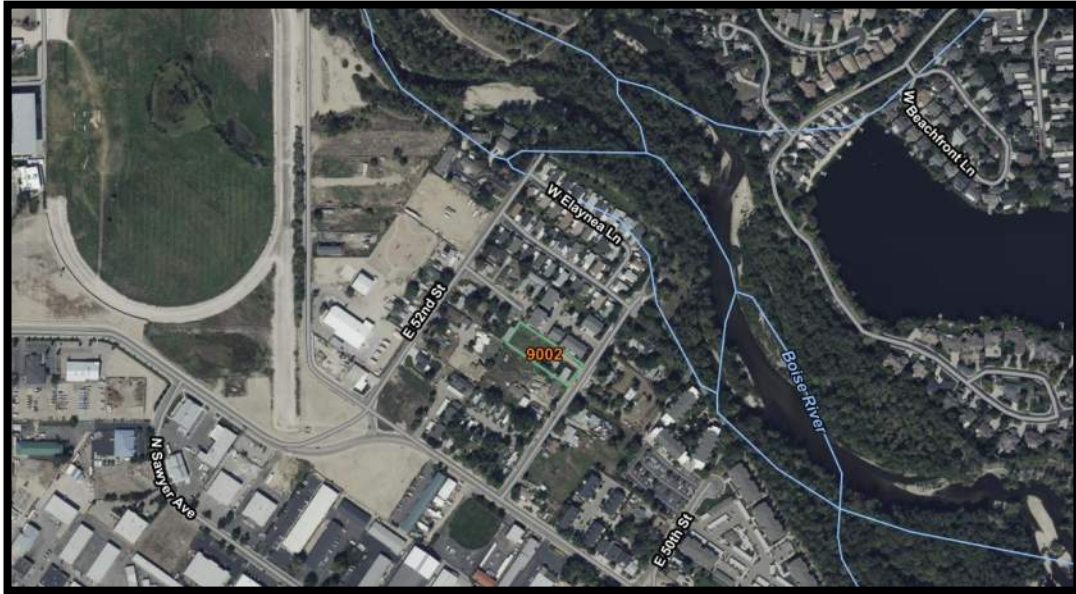


Figure 1. Soil Survey Map

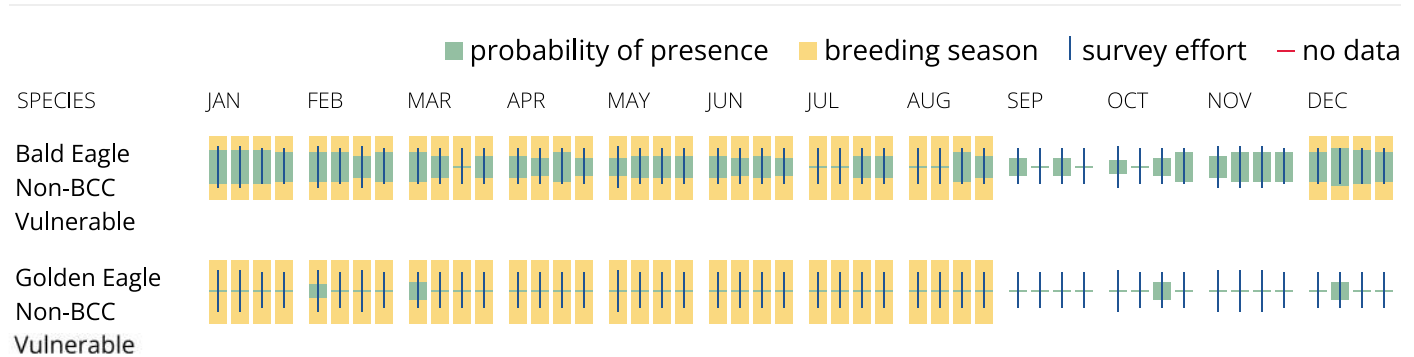

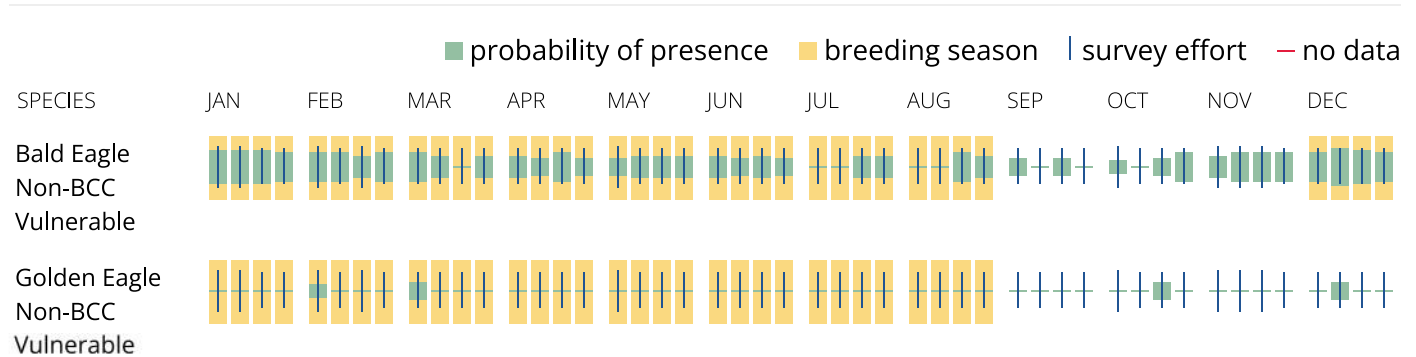

For example, imagine the probability of presence in week 20 for the Spotted Towhee is 0.05, and that the probability of presence at week 12 (0.25) is the maximum of any week of the year. The relative probability of presence on week 12 is $0.25/0.25 = 1$; at week 20 it is $0.05/0.25 = 0.2$.
3. The relative probability of presence calculated in the previous step undergoes a statistical conversion so that all possible values fall between 0 and 10, inclusive. This is the probability of presence score.

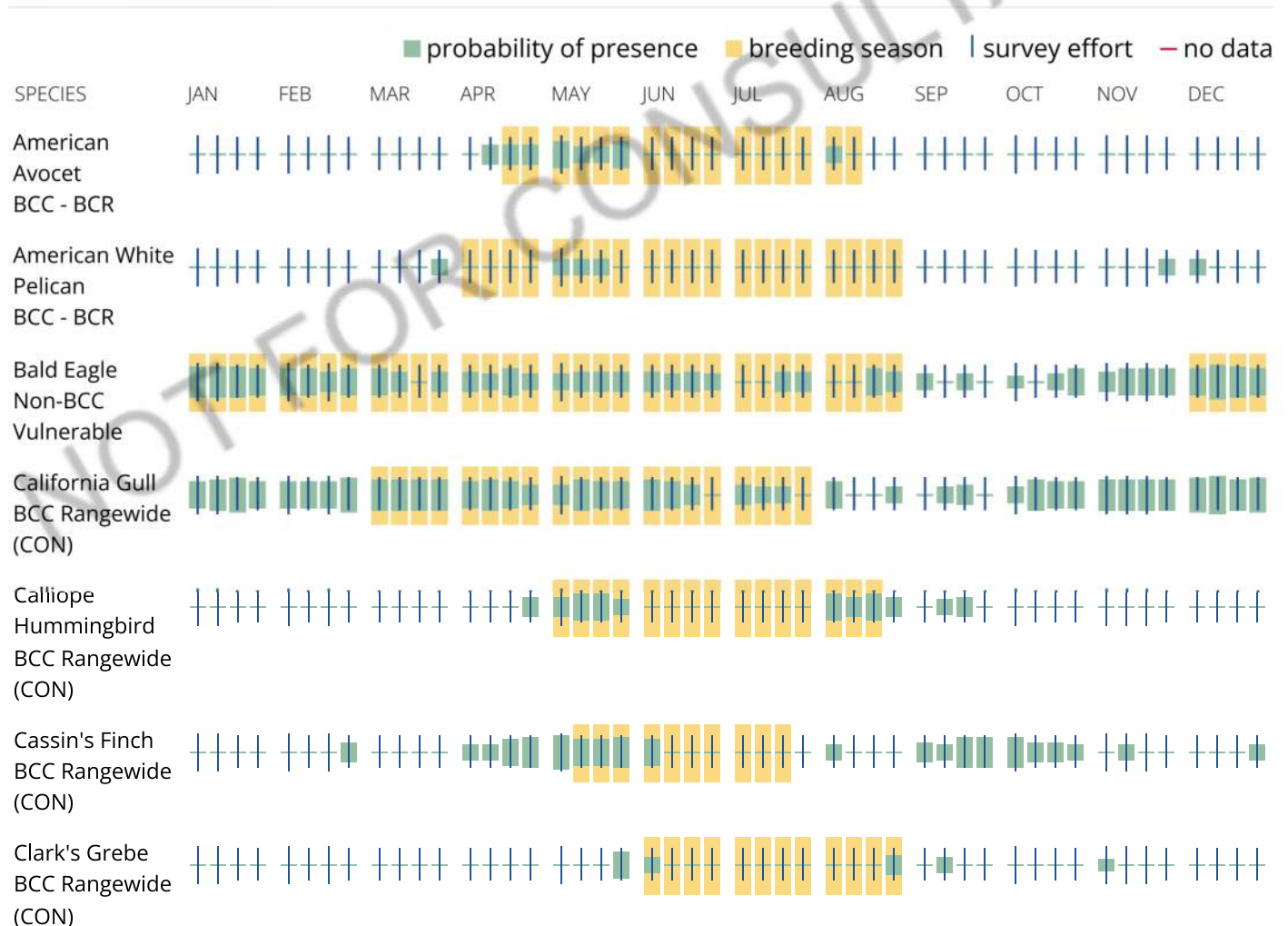
To see a bar's probability of presence score, simply hover your mouse cursor over the bar.

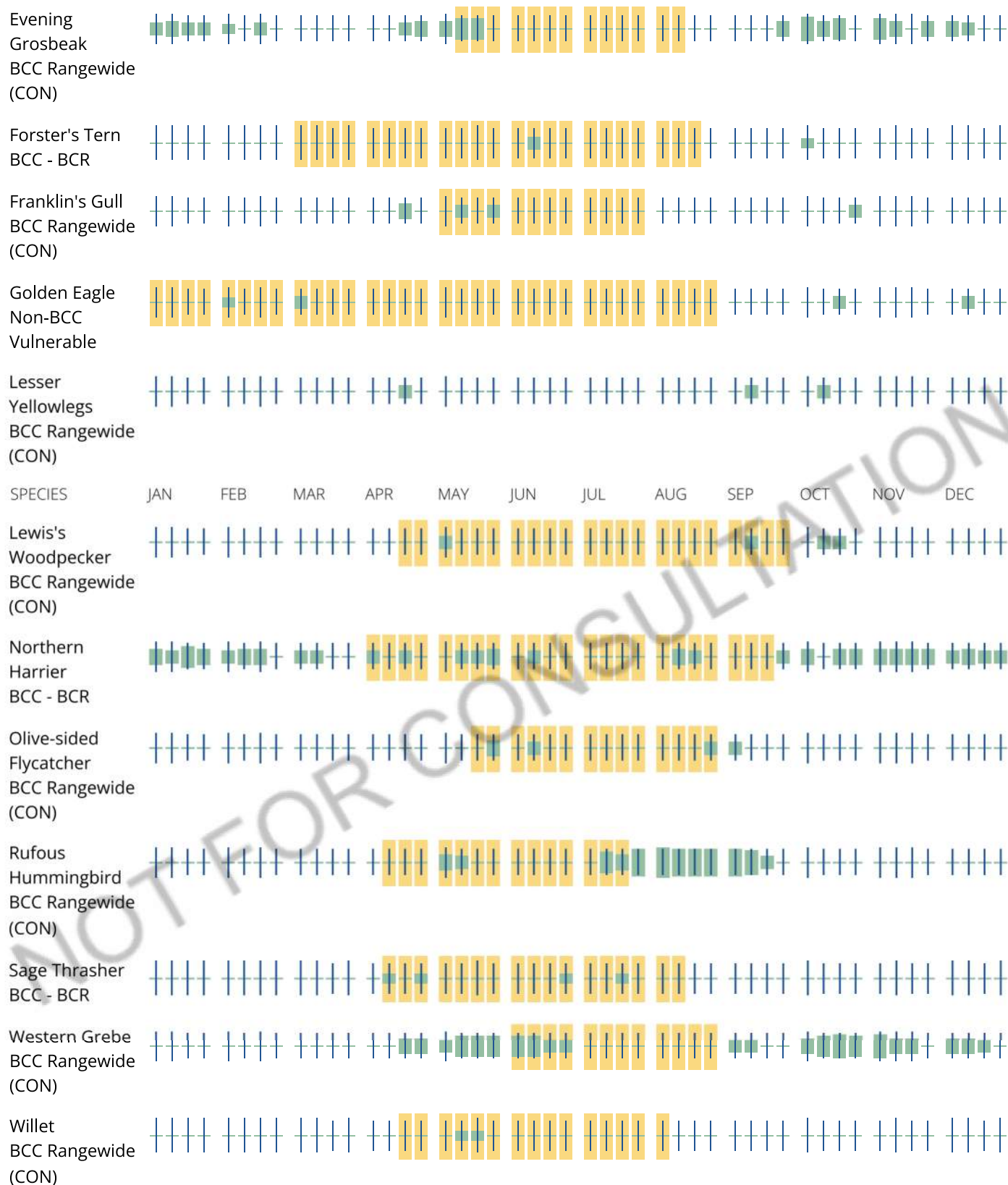
Yellow bars denote a very liberal estimate of the time-frame inside which the bird breeds across its entire range. If there are no yellow bars shown for a bird, it does not breed in your project area.

Vertical black lines superimposed on probability of presence bars indicate the number of surveys performed for that species in the 10km grid cell(s) your project area overlaps. The number of surveys is expressed as a range, for example, 33 to 64 surveys.

A week is marked as having no data if there were no survey events for that week.

Surveys from only the last 10 years are used in order to ensure delivery of currently relevant information. The exception to this is areas off the Atlantic coast, where bird returns are based on all years of available data, since data in these areas is currently much more sparse.





Tell me more about conservation measures I can implement to avoid or minimize impacts to migratory birds.

[Nationwide Conservation Measures](#) describes measures that can help avoid and minimize impacts to all birds at any location year round. Implementation of these measures is particularly important when birds are most likely to occur in the project area. When birds may be breeding in the area, identifying the locations of any active nests and avoiding their destruction is a very helpful impact minimization measure.

What does IPaC use to generate the list of migratory birds that potentially occur in my specified location?

The Migratory Bird Resource List is comprised of USFWS [Birds of Conservation Concern \(BCC\)](#) and other species that may warrant special attention in your project location.

The migratory bird list generated for your project is derived from data provided by the [Avian Knowledge Network \(AKN\)](#). The AKN data is based on a growing collection of [survey, banding, and citizen science datasets](#) and is queried and filtered to return a list of those birds reported as occurring in the 10km grid cell(s) which your project intersects, and that have been identified as warranting special attention because they are a BCC species in that area, an eagle ([Eagle Act](#) requirements may apply), or a species that has a particular vulnerability to offshore activities or development.

Again, the Migratory Bird Resource list includes only a subset of birds that may occur in your project area. It is not representative of all birds that may occur in your project area. What does IPaC use to generate the probability of presence graphs for the migratory birds potentially occurring in my specified location?

The probability of presence graphs associated with your migratory bird list are based on data provided by the [Avian Knowledge Network \(AKN\)](#). This data is derived from a growing collection of [survey, banding, and citizen science datasets](#).

Probability of presence data is continuously being updated as new and better information becomes available. How do I know if a bird is breeding, wintering or migrating in my area?

To see what part of a particular bird's range your project area falls within (i.e. breeding, wintering, migrating or year-round), you may query your location using the [RAIL Tool](#) and look at the range maps provided for birds in your area at the bottom of the profiles provided for each bird in your results. If a bird on your migratory bird species list has a breeding season associated with it, if that bird does occur in your project area, there may be nests present at some point within the timeframe specified. If "Breeds elsewhere" is indicated, then the bird likely does not breed in your project area.

What are the levels of concern for migratory birds?

Migratory birds delivered through IPaC fall into the following distinct categories of concern:

1. "BCC Rangewide" birds are [Birds of Conservation Concern](#) (BCC) that are of concern throughout their range anywhere within the USA (including Hawaii, the Pacific Islands, Puerto Rico, and the Virgin Islands);
2. "BCC - BCR" birds are BCCs that are of concern only in particular Bird Conservation Regions (BCRs) in the continental USA; and
3. "Non-BCC - Vulnerable" birds are not BCC species in your project area, but appear on your list either because of the [Eagle Act](#) requirements (for eagles) or (for non-eagles) potential susceptibilities in

offshore areas from certain types of development or activities (e.g. offshore energy development or longline fishing).

Although it is important to try to avoid and minimize impacts to all birds, efforts should be made, in particular, to avoid and minimize impacts to the birds on this list, especially eagles and BCC species of rangewide concern. What if I have eagles on my list?

Proper Interpretation and Use of Your Migratory Bird Report

The migratory bird list generated is not a list of all birds in your project area, only a subset of birds of priority concern. To learn more about how your list is generated, and see options for identifying what other birds may be in your project area, please see the FAQ "What does IPaC use to generate the migratory birds potentially occurring in my specified location". Please be aware this report provides the "probability of presence" of birds within the 10 km grid cell(s) that overlap your project; not your exact project footprint. On the graphs provided, please also look carefully at the survey effort (indicated by the black vertical bar) and for the existence of the "no data" indicator (a red horizontal bar). A high survey effort is the key component. If the survey effort is high, then the probability of presence score can be viewed as more dependable. In contrast, a low survey effort bar or no data bar means a lack of data and, therefore, a lack of certainty about presence of the species. This list is not perfect; it is simply a starting point for identifying what birds of concern have the potential to be in your project area, when they might be there, and if they might be breeding (which means nests might be present). The list helps you know what to look for to confirm presence, and helps guide you in knowing when to implement conservation measures to avoid or minimize potential impacts from your project activities, should presence be confirmed. Data limitations

The Service's objective of mapping wetlands and deepwater habitats is to produce reconnaissance level information on the location, type and size of these resources. The maps are prepared from the analysis of high altitude imagery. Wetlands are identified based on vegetation, visible hydrology and geography. A margin of error is inherent in the use of imagery; thus, detailed on-the-ground inspection of any particular site may result in revision of the wetland boundaries or classification established through image analysis.

The accuracy of image interpretation depends on the quality of the imagery, the experience of the image analysts, the amount and quality of the collateral data and the amount of ground truth verification work conducted. Metadata should be consulted to determine the date of the source imagery used and any mapping problems.

Wetlands or other mapped features may have changed since the date of the imagery or field work. There may be occasional differences in polygon boundaries or classifications between the information depicted on the map and the actual conditions on site.

Data exclusions

Certain wetland habitats are excluded from the National mapping program because of the limitations of aerial imagery as the primary data source used to detect wetlands. These habitats include seagrasses or submerged aquatic vegetation that are found in the intertidal and subtidal zones of estuaries and nearshore coastal waters. Some deepwater reef communities (coral or tubercid worm reefs) have also been excluded from the inventory. These habitats, because of their depth, go undetected by aerial imagery.

Data precautions
