They didn't change the building orientation... but they did mention:

The rooftop deck was modified to be on the west side of the building, to pull site lines away from the Garden City PD Property. Additionally, all units on the east side of the building will be provided with windows that open out only to the north and will include tempered glass windows to help mitigate the concerns of the police department.

You can see the rotation of the rooftop deck amenities on Sheet L101. Their elevations/facades facing the PD appear to still have balconies and windows.

We can create specific conditions of approval that might be appropriate for the safety. But they didn't change anything based on the premise of code not requiring it.

Specifically noted in their documents:

Staff Comment “The rooftop deck might pose future safety concerns regarding its location adjacent to the Garden City PD property. See discussion.”

Response: Per comments under 8-4B-4, no specific “concerns” were identified or provided as it relates to the structure’s proximity to the Garden City PD property.

Applicant is open to specific conditions, however there are no specific code requirements that limit structural requirements near and around police stations or any other public building. Additionally, the building would provide no sight lines to the rear of the building which provides parking for police officers and where inmates are brought into the facility. Any safety concerns are no different than the currently surrounding commercial properties that directly abut the Garden City PD Property. The rooftop deck was modified to be on the west side of the building, to pull site lines away from the Garden City PD Property. Additionally, all units on the east side of the building will be provided with windows that open out only to the north and will include tempered glass windows to help mitigate the concerns of the police department.
