THIS MATTER came before the Garden City, Planning and Zoning Commission for consideration on December 21, 2022. The Planning and Zoning Commission reviewed the application and materials submitted. Based on the evidence presented, pursuant to Garden City Code Table 8-6A-1, the Planning and Zoning Commission makes the following Findings of Fact, Conclusions of Law and Recommendation:

FINDINGS OF FACT

1. The applicant is the Garden City.
2. The application is to amend processes for financial sureties.
3. The following section of the Garden City Development Code are amended by this proposal:
