Tree Assessment for Carolyn Circle & Arabella Lofts

Proposed Removals:

1. Spruce 17 ¾ DBH Split trunk with a co-dominant stem
2. White Ash 18 ½" has bores and is in declining health and not a viable tree.
3. Sweet Gum 10 ½" Dead

Arborist Observations:

1. Spruce tree has a split trunk with a co-dominant stem which is not desirable. The co-dominant stem has included bark which makes this stem unstable and prone to splitting.
2. White Ash is infected with bores and is declining in health.
3. 2 Austrian Pine trees 27" and 25 1/2" DBH. Both trees are in good health and are viable trees.

In my opinion, the only 2 trees that would be subject to mitigation would be the two Austrian Pines. The other 3 trees are either dead or not in savable health or is a hazard.

Proposed Removals:

1. Spruce 17 ¾ DBH Split trunk with a co-dominant stem
2. White Ash 18 ½" has bores
3. Sweet Gum 10 ½" Dead

1. Spruce tree has a split trunk with a co-dominant stem which is not desirable. The co-dominate stem has included bark which makes this stem unstable and prone to splitting.
2. White Ash is infected with bores and is declining in health.
