

Dan Hollar, Public Testimony, Garden City Council, June 12, 2023

My name is Dan Hollar and we have lived at 6254 N. Fair Oaks Place in Garden City the last 29 years.

We are opposed to this SAP application for the following reasons:

Plantation Homeowners Association

The current Plantation Homeowner Association's Master Declaration Contract, which applies to the Plantation Subdivision, its residents, as well as the entire golf course, remains in force and operative and therefore needs to be considered and adhered to with regard to any proposed development involving the 243 acres now known as the River Club property.

The Master Declaration Contract requires that the property rights of homeowners in the neighborhood need to be addressed for any changes in zoning or for development by any member of "The Plantation" development—including the golf course—which is a property owner in the neighborhood. Therefore, the owner or owners of the River Club property are prevented from developing the property because of constraints and prohibitions contained in the Master Declaration of covenants and restrictions applicable to all lots in the Plantation neighborhoods. The golf course property is a "lot" subject to those limitations, and therefore the owner of the golf course property is subject to those limitations, as are other property owners. As members of the elected Garden City Council, I believe you have a responsibility to recognize, respect and require compliance with the Master Declaration.

With this in mind, it is worth noting that in the Plantation Master Association Newsletter dated June 2013 it is written that HOA CC&Rs are enforceable and it references how the Idaho State Supreme Court agrees "in the many cases that have come before it....."

*It's also interesting to note that Mr. Kent Brown was the Plantation Master Association Director at Large at the time this newsletter was published, and, as current Vice Chair of Garden City's Planning and Zoning Commission, Mr. Brown also voted for the **approval** of the SAP application on May 24, 2023. This appears to be in conflict with the Master Declaration Contract and warrants reconsideration of the P&Z recommendation for approval.*

Ownership of Property

With regard to ownership of the property, the ownership issue of the River Club is still unresolved and has remained a concern as outlined by the City of Garden City in a communication from the City Attorney to The City of Garden City in a letter from July of 2022. It would stand to reason that the City of Garden City, in order to protect its citizens from possible default of said development, should require a financial audit to address the question of ownership and determine financial solvency in order to complete the project as is being proposed. This would be in keeping with a commitment to transparency, as has been earlier indicated by the developer.

Specific Area Plan (SAP) Applicability

- The amended Specific Area Plan (SAP) to build the proposed development is inconsistent with the State Specific Use Permit (SUP) Statute and Garden City's Comprehensive Plan & Code.

- The property in the application, especially the Phase 3 area, does not meet the City's definition as to where an SAP is applicable. According to Ordinance 8-6B-6, "an SAP application is encouraged for the development or redevelopment of properties defined in Garden City Comprehensive Plan as Transit Oriented Development (TOD) Activity Nodes, or as Neighborhood Destination Activity Nodes, or as Future Planning Areas". The Phase 3 area, as identified on the Future Land Use Map, is designated for no other use other than Park/Open Space.
- Additionally, Pierce Park is NOT a Transit Oriented Activity Node in the State Street Corridor Study. The study identifies 4 TOD Activity Nodes; Whitewater, Collister, Glenwood and Horseshoe Bend roads.
- Furthermore, the State Street Corridor Study recommends higher density within a ¼ mile of TOD Activity Nodes and therefore it is not applicable to the 22 acres proposed in the SAP application (**especially NOT the area near North Fair Oaks Place or Charleston Place - identified as Phase 3 of the proposed development**).
- There is some relevance in the application to the Neighborhood Destination Activity Node, which is on the Comprehensive Plan Future Zoning Map and is identified as State Street and Pierce Park (identified as Phases 1 and 2 of the proposed development). However, **it certainly does NOT extend off of State Street near North Fair Oaks Place or Charleston Place (identified as Phase 3)**.
- As to Code 8-5B-6, Phase 3 of the SAP is not consistent with the Garden City Comprehensive Plan, Future Land Use Map, guidelines and designation and is in conflict with the adjacent R-2 neighborhood, in that it:
 - Contains no adequate zoning standards or design regulations
 - Threatens damage to a distinctive neighborhood
 - Allows damage to existing neighborhood traffic patterns
 - Eliminates open space and landscape
 - Does not provide development that is compatible in height and scale with the existing neighborhoods
 - Does not promote the orderly planning and development of an existing R-2 neighborhood
 - Is contrary to the requirements of Code 8-6B-6, in that it does not develop "in a manner highly respectful of the natural setting" or "ensure neighborhood compatibility" or protect (an) open site in perpetuity"
- In short, Phase 3 is a threat to the existing neighborhood with no functional SAP purpose.

Furthermore, this SAP Application is in direct conflict with numerous requirements and goals as stated in Garden City Municipal Code Title 8 Development Code, specifically:

- Section 8-4A-1 – Purpose: "A) To ensure that the development of property protects the public, health, safety and welfare of the community; B) To protect property values and rights of all residents; C) To protect and enhance the community's assets and natural resources."
- Section 8-6B-6 Specific Area Plan: "The goal of this section is to ensure the orderly planning and development of land, by **REQUIRING** new development to:
 - Implement the goals and objectives of the city's Comprehensive Plan, including the Future Land Use Map;
 - Contribute to the social, economic and environmental sustainability of the city; Develop in a manner that is highly respectful of the natural setting; that is at a human scale and **ensures neighborhood compatibility**;
 - Designate and protect open site area in perpetuity;
 - Remain consistent with the intent of this title."

The SAP application DOES NOT MEET the requirements for an SAP and it certainly does not protect the health, safety and welfare of the community and is certainly NOT compatible with the existing neighborhood.

- The legal property in question is nearly 243 acres and the "Master Plan" of the full 243 acres should be included in the SAP application, per applicable Garden City Code, unless the 22 acres is being subdivided but we have not seen an application in that regard. The 22 acres is being split out for spot zoning, which constitutes improper "spot zoning" under Idaho case law. Garden City's own Rezone website specifically and clearly states: "The essential things to keep in mind is that the rezone can't constitute 'spot zoning', and it must be consistent with the Comprehensive Plan."
- The elimination of a Future Land Use Map area identified for "Future Parks/Open Space" and "Green Boulevard Corridor" by a small, localized and inconsistent zoning area, will have negative impacts to existing neighbors and Garden City citizens, and could constitute "Type Two" spot zoning under Idaho case law. In short, thrusting Phase 3 into a developed R2 neighborhood is readily discernible as Type 2 spot zoning.

Summary

- In summary, as members of the Garden City Council you should NOT make the findings required under Garden City Ordinance and Development Code Section 8-6B-6, Specific Area Plan, to approve this Application. Per Garden City Municipal Code Title 8 Development Code all of the six factual findings stated therein must be made. This proposal fails, in that it:
 1. Is not "consistent with the Garden City Comprehensive Plan, as amended, including the future land use map"...
 2. Does not promote "the orderly planning and development of land. ...", and
 3. Does not comply "with all city zoning regulations and codes in effect at the time of the SAP application."

Garden City Code clearly states:

"If an application does not meet one or more of the criteria above, the application shall be denied, and the reason the application does not meet the finding or findings shall be in writing."

TESTIMONY BEFORE THE CITY COUNCIL OF GARDEN CITY,

IN REGARD TO SAFY2023-001, JUNE 12, 2023.

MAYOR EVANS AND COUNCIL MEMBERS, MY NAME IS
RONALD BUSH. I AM A CITIZEN OF GARDEN CITY, RESIDING
AT 3695 N. GRAMARCY LANE.

Mayor Evans and Members of the Garden City Council, my name is
Ronald Bush. I am a citizen of Garden City, residing at 3695 N.
Gramarcy Lane. I have asked DEB RIEDEL to read my
testimony into your record at tonight's meeting as I will be somewhere
over the Atlantic Ocean at the time of the meeting, on a long-planned
trip with my daughter who has been teaching for the last year in France.
It will be a memorable trip, of course, with a translator and guide who
also happens to be the apple of my eye. But I do very much regret that
I cannot be there to address you in person. *I am traveling
outside the country.*

Thank you for your serious and thoughtful consideration of this dispute.
It is, as I have mentioned in prior meetings, a watershed moment for
this city. Whatever may become of this application in whatever final
forum that may be, the details of its process to this point and this
Council's decision will be studied, written about, and commented upon
in many circles, not just in City Hall or in Garden City. You feel the
weight of it, I am sure. It is a weight that also sits on the minds and
hearts of many of your fellow citizens.

I have lived for more than a few trips of the sun around the earth, but
never have I been involved in an endeavor so extraordinary as the
opposition against this proposed development, an endeavor in which
too many good people, to fully count, have rallied to defend their homes

and their way of life, and to defend their neighbors' homes and their neighbors' way of life. People from many backgrounds, people who have created a wonderful community and who take pride in their homes and neighborhood. I could not be prouder of the conviction and the passion they have in taking up this battle. I could not be prouder of the substantive and compelling case they have made, based on the facts and Garden City code, that calls out loudly and eloquently for denial of the application.

I first became involved in the opposition to this proposed development because I was astonished at the audacity and hubris of the proposal. The astonishing number and size of the proposed buildings. The astonishing number of proposed multi-family units. The astonishing number of people who would live in such units and the astonishing number of cars and trucks, noise, traffic, overcrowding and other greatly negative impacts upon the existing neighborhoods single family home environment, especially for those of our neighborhood who live most immediately adjacent to the location of the proposed development.

It is remarkable ⁱⁿ ~~is~~ so many ways that such a proposal could ever get to this point, when the existing residential areas of the city which are most impacted by the development, have been in place for decades, some of them dating to the 1970s and 1980s. But the fact that the proposed development is before you tonight is the culmination of a plan of attack upon those neighborhoods, for the benefit of the golf course developer, that began more than three years ago, when Mr. Taunton sent an email to Jenah Thornborrow, copied to JoAnn Butler, dated May 5, 2020, in which he said:

Hi Jenah,

"JoAnn and I have spent some time exploring a code amendment for the 8- 6B-6 Specific Area Plan. We believe that with some additions adopted from Boise's Specific Plan Districts code and some rework of the existing language, the SAP *can be transformed into a powerful planning tool for Garden City and developers.*"

Mr. Taunton included a draft amended version of the Garden City Specific Area Plan code and asked for a meeting as soon as possible with Ms. Thornborrow and Mr. Wadams. In short order, the proposed amendment was in front of the city planning bodies and later the council. Now, three years later, we know exactly what the "transformed powerful planning tool for Garden City and developers" really looks like. The tragedy, of course, for today and for the future, is that the missing piece -- just as it was missing in May of 2020, is that this "transformed powerful planning tool for Garden City and developers" has never meaningfully involved existing communities in our City, such as the Plantation subdivisions. That could have been done at any time at the direction of the City, or by the developer itself, as happened in a significant and meaningful way with Boise's Harris Ranch SAP development, with multiple, planned, substantive meetings over several months involving multiple stakeholders. Such public involvement also could have been done on an ad hoc basis just as has occurred with many other major SAP process undertaken in the Treasure Valley. But that did not happen with this application.

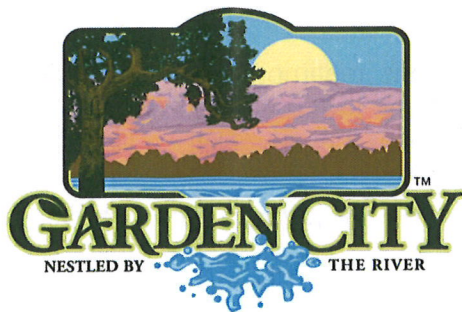
I have heard people say about this application that "high-density development is inevitable along State Street" and "how are you going to stop them?" Well, the legitimate reasons for saying no to such development as proposed in this application is before you in the comments and testimony made in opposition. But the discouragement contained and cynicism of such statements is commonplace in our city

and elsewhere in the Treasure Valley. So also, are the comments about how miserable commutes have become, how horrible and dangerous connector street traffic has become, and how overcrowding has negatively impacted our schools, our recreation, and our basic enjoyments.

So, I ask the question. Who says that high-density development is required and inevitable? Here, the zoning doesn't allow for it. Only a decision by this Council that would eliminate the protections of single-family zoning would allow it. Why is that a good idea? It all seems backward --to build EXTREMELY dense housing next to single-family neighborhoods, exacerbate population growth problems, greatly diminish and in some instances effectively destroy the quality of life of our existing citizens who live in those single-family neighborhoods, and then justify repeating the process repeatedly because we allowed the harm in the first instance.

What is lost if the application is denied? What if you tell the developers (whoever they may be, since they apparently don't want to be identified -- why not, I continue to ask?), what if you tell the developers that they are bound by what they bought -- that is, R-2 single-family residential zoning. The same zoning the Plantation homeowners purchased, what they are bound with, and what they hope they will be able to continue to live with ^{for} more many years to come, in the manner the City promised to them when they built or purchased their homes and in the manner in which they have kept that promise with the City for these many years.

Please keep that promise intact. Tonight, and into the future. By denying this application, you honor that promise, and you honor the promise the existing homeowners have kept and rely upon, each day. Thank you.

Oppose Pedestrian & Vehicular Circulation Plan

Comments:

My name is Virginia Morris. My address is 4636 Savannah Lane and I have been a resident of the Lake Plantation Subdivision ~~for~~ since July 1, 1989. I purchased the very first home in the development and served on its first Homeowner's Association board. As such, I have practical experience implementing Garden City's approval conditions for developers related to the minimizing impact of increased density on current residents.

Feb 1989 + March 1989

In early ~~1989~~, both Garden City Planning and Zoning and the City Council approved conditions to deter traffic on Savannah Lane which included a gate at the Glenwood entrance and speed humps in front of the existing townhouses. Even with a private gate, controlling access to our street has been a challenge for 34 years. ** For example* Club members from Riverside Village have driven carts around our gate, over lawns, and even purchased "bootleg" gate remotes. Non-residents still attempt to access Glenwood hoping the gate is open and then must turn around and drive back out, usually at faster speeds. Golf course maintenance crews often use our street to access the west end of the course. Commuter and recreational bicyclists regularly use it as an extension of the Greenbelt. Signage and speed humps have achieved limited results. *OK to access*

** and has been more difficult as population increases*

In addition, the ~~approved~~ ¹⁹⁸⁹ conditions stipulated the installation and maintenance costs for these deterrents were to be decided between the developer and the homeowners. You can guess how that turned out. We residents bear ALL the costs for street and gate maintenance and repair. As such, we have a propriety interest in its increased wear and tear when density will be increased by 1,107 additional vehicles using the new development's parking spaces. Also worth mentioning is the disturbance to the peaceful conditions a private street is intended to provide when the residents of 750 new households try to ~~access~~ ^{reach} the greenbelt at Glenwood *even large landscape rocks*

*** The Developer refused to contribute as Homeowners paid for all costs for driveway and open access.*

I raised with Mr. Gustafson the need to control vehicle and pedestrian access to Savannah Lane at one of the earlier neighborhood meetings. While I was pleased that he agreed this needed to be addressed, ~~my~~ ^{on 15} concern is that the only slide in tonight's presentation that even acknowledges our street's existence is the Pedestrian & Vehicular Circulation slide. That slide appears to funnel all west bound traffic with a bold arrow labeled "Main Vehicular Circulation" as it points to "River Club Parking/Access to Savannah Lane". This same slide clearly delineates public access restrictions for the east side of the development to mitigate density impact to two public streets that have 25 fewer homes than private Savannah Lane. As Mr. Gustafson remarked at the time, adding a barrier such as a gate would be "peanuts" compared to the cost
