

RESOLUTION NO. 1214-25

BY THE COUNCIL: JACOBS, JORGENSEN, PAGE, RASMUSSEN

A RESOLUTION AMENDING THE BILLING POLICY OF THE CITY OF GARDEN CITY, PURSUANT TO TITLE 6, CHAPTER 3 OF THE MUNICIPAL CODE, INCREASING OR ADDING CERTAIN UTILITY FEES; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the City Council is authorized by Title 6, Chapter 3 of the municipal code, to set utility rates by resolution equivalent to the cost of operation of the utility system; and,

WHEREAS, THE City Council recognizes and acknowledges the need for the City to adjust fees as it becomes necessary.

NOW THEREFORE BE IT RESOLVED by the Mayor and Council of the City of Garden City, Idaho that Garden City Resolution 1181-24 is adjusted upon passage of this resolution, and the Utility Fees as enumerated in Exhibit A shall be in effect and in place for the utility fees as shown in Resolution 1214-25 starting October 1, 2025 for water, sewer and sanitary (trash) services.

IT IS FURTHER RESOLVED that this resolution shall be in full force and effect immediately upon its adoption and approval.

Sewer Disposal and Treatment Charges: The following criteria shall be used to determine sewer use fees and is based on volume and strength of the waste discharged by the different categories of sewer users. Residential sewer services provided shall be billed from April through November based on a winter average rate equal to the average monthly water consumption from December through March readings. Sewer consumption will be billed based on actual usage from December through March. The maximum sewer consumption (Winter Average) will be adjusted each year in April.

Non-residential sewer services may be billed similar to residential taking into consideration the use of City water for irrigation purposes.
