**AN ORDINANCE BY THE CITY OF GARDEN CITY, A MUNICIPAL CORPORATION PROVIDING FOR REZONE OF CERTAIN REAL PROPERTY DESCRIBED HEREIN FROM R-3 MIXED USE RESIDENTIAL TO R-M MEDIUM DENSITY RESIDENTIAL; AMENDING THE ZONING MAP OF THE CITY OF GARDEN CITY TO REFLECT SAID CHANGES IN ORDER TO BETTER ALIGN WITH THE FUTURE LAND USE MAP, TO IMPLEMENT THE COMPREHENSIVE PLAN MORE EFFECTIVELY, AND TO REFLECT THE CITY COUNCIL'S ADOPTION OF RELATED DISCUSSIONS; PROVIDING FOR SEVERABILITY; APPROVING A SUMMARY OF THE ORDINANCE; AND PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, the City of Garden City, Idaho is a municipal corporation organized and operating under the laws of the State of Idaho; and

**WHEREAS**, pursuant to Chapter 65, Title 67, Idaho Code, the City of Garden City has the authority to adopt, establish and amend a Zoning Ordinance; and

**WHEREAS**, the real properties subject to this ordinance, addressed as 6023 **N GARRETT ST**; 6030, 6031, 6042, 6043, 6054, 6055, 6066, 6067, and 6088 **N FRANCIS PL**; 6170, 6171, 6178, 6187, 6192, 6195, 6202, 6208, 6211, 6218, 6219, 6226, and 6227 **N ETHAN PL**; 9346, 9368, 9390, 9412, 9434, 9456, 9478, 9500, 9522, 9544, 9545, 9566, 9567, 9589, and 9602 **W MARIGOLD ST**; 9624, 9633, 9634, 9638, 9641, 9642, 9648, 9649, 9657, 9658, 9665, 9666, 9671 **and W HOFF DR**; and bare land assigned Ada County Assessor tax parcel R7608900120, currently zoned R-3 Medium Density Residential and is more particularly described in Exhibit A, which is attached hereto and incorporated herein by reference; and

**WHEREAS**, the City Council has requested a rezone of the property more particularly described in Exhibit A, currently zoned R-3 Mixed-use Residential, to R-M Medium Density Residential; and

**WHEREAS**, the City Council of the City of Garden City has determined that the zone change is in accordance with the Comprehensive Plan and Future Land Use Map of the City of Garden City; and

**WHEREAS**, the City Council of the City of Garden City has determined that the zoning map amendment complies with the regulations outlined for the proposed district, specifically the purpose statement; and

**WHEREAS**, the City Council of the City of Garden City has determined that the zoning map amendment is not materially detrimental to the public health, safety, or welfare of the community; and

**WHEREAS**, the City Council of the City of Garden City has determined that the zoning map amendment does not result in an adverse impact upon the delivery of services by any political subdivision providing public services within the city including, but not limited to, school districts; and

**WHEREAS**, the City Council of the City of Garden City has determined that the zoning map amendment will not create an adverse impact upon the delivery of services.

**WHEREAS**, the City Council have determined that good cause exists for amending the official zoning map of the City of Garden City.

**NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF GARDEN CITY, ADA COUNTY, IDAHO:**

**SECTION 1:** The real properties more fully depicted on Exhibit A are hereby rezoned to R-M Medium Density Residential.

**SECTION 2.** The official Zoning Map of the City of Garden City, Idaho, is hereby amended to reflect the foregoing change in zoning classification.

**SECTION 3:** If any provision or section of this Ordinance shall be held to be invalid by a court of component jurisdiction, then such provision or section shall be considered separately and apart from the remaining provisions or sections of this Ordinance, which shall remain in full force and effect.

**SECTION 4:** That the summary of the Ordinance, attached hereto as Exhibit C, is hereby approved as to both form and content.

**SECTION X** Pursuant to an affirmative vote of one-half (1/2) plus one (1) of the members of the full Council, the rule requiring two (2) separate readings by title and one (1) reading in full be, and the same is hereby, dispensed with and accordingly, this Ordinance is passed and adopted.

**SECTION 5:** This ordinance shall be in full force and effect from and after passage, approval, publication of the ordinance.
