DSRFY2026-0003: Design Review: Chad Jones with ALC Architecture is requesting Design Review approval for the construction of one 3-story 18-plex, two 3-story 12-plex multi-family buildings and a 1-story Clubhouse with an open mezzanine located at 212 W. 41st St., Ada County Parcel #R2734510560, in the C-2 Mixed-Use Commercial Zoning District. **We didn't see the size of the enclosure that you show on the drawing. Our design standards require at least 12'x18' for the enclosure(one trash and one recycling container with doors that open at least 120 degrees and are staked.**

DSRFY2026-0004: Design Review: Erik Hagen with Erik Hagen Architecture is requesting Design Review approval for the construction of a new 5,400 sqft. 1-story office building on a developed lot in an existing commercial development located at 6655 N. Glenwood St., Ada County Parcel #R3691210042, in the C-2 Mixed-Use Commercial Zoning District.
