AN ORDINANCE BY THE CITY OF GARDEN CITY, A MUNICIPAL CORPORATION PROVIDING FOR REZONE OF CERTAIN REAL PROPERTY DESCRIBED HEREIN FROM C-2 MIXED USE COMMERCIAL TO C-1 HIGHWAY COMMERCIAL; AMENDING THE ZONING MAP OF THE CITY OF GARDEN CITY TO REFLECT SAID CHANGE; PROVIDING FOR SEVERABILITY; APPROVING A SUMMARY OF THE ORDINANCE; AND PROVIDING AN EFFECTIVE DATE

WHEREAS, the City of Garden City, Idaho is a municipal corporation organized and operating under the laws of the State of Idaho; and

WHEREAS, pursuant to Chapter 65, Title 67, Idaho Code, the City of Garden City has the authority to adopt, establish and amend a Zoning Ordinance; and

WHEREAS, the real property located at 4902 W. Chinden Blvd. in Garden City, particularly described as PAR #4750 OF W2 IN FLOOD DIST SEC 31 4N 2E #244831-R, Subdivision 4N 2E 31, Ada County Tax Parcel #S0631244750, more fully depicted by the Legal Description, **Exhibit A**, is presently zoned C-2 Mixed Use Commercial under the zoning ordinance of Garden City; and

WHEREAS, the real property located at 4902 W. Chinden Blvd. in Garden City, particularly described as PAR #4751 OF W2 OUT OF FLOOD DIST SEC 31 4N 2E #244830-R, Subdivision 4N 2E 31, Ada County Tax Parcel #S0631244751, more fully depicted by the Legal Description, **Exhibit B**, is presently zoned C-2 Mixed Use Commercial under the zoning ordinance of Garden City; and

WHEREAS, the property owner has requested a rezone of the property more particularly described in Exhibits A & B, currently zoned C-2 Mixed Use Commercial, to C-1 Highway Commercial under the zoning ordinance of Garden City; and

WHEREAS, the City Council of the City of Garden City has determined that the zone change is in accordance with the Comprehensive Plan of the City of Garden City and the Future Land Use Map of the City of Garden City; and

WHEREAS, the City Council of the City of Garden City has determined that the zoning map amendment complies with the regulations outlined for the C-1 Highway Commercial Zoning District, specifically the purpose statement; and

WHEREAS, the City Council of the City of Garden City has determined that the zoning map amendment is not materially detrimental to the public health, safety, or welfare of the community; and

WHEREAS, the City Council of the City of Garden City has determined that the zoning map amendment will not create an adverse impact upon the delivery of services.

WHEREAS, the Mayor and Council have determined that good cause exists for amending the official zoning map of the City of Garden City.

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF GARDEN CITY, ADA COUNTY, IDAHO:

SECTION 1: The real properties more fully depicted on Exhibit A are hereby rezoned to C-1 Highway Commercial.

SECTION 2. The real properties more fully depicted on Exhibit B are hereby rezoned to C-1 Highway Commercial.

SECTION 3: The official Zoning Map of the City of Garden City, Idaho, is hereby amended to reflect the foregoing change in zoning classification.

SECTION 4: If any provision or section of this Ordinance shall be held to be invalid by a court of component jurisdiction, then such provision or section shall be considered separately and apart from the remaining provisions or sections of this Ordinance, which shall remain in full force and effect.

SECTION 5: That the summary of the Ordinance, attached hereto as **Exhibit C**, is hereby approved as to both form and content.

SECTION 6: Pursuant to an affirmative vote of one-half (1/2) plus one (1) of the members of the full Council, the rule requiring two (2) separate readings by title and one (1) reading in full be, and the same is hereby, dispensed with and accordingly, this Ordinance is passed and adopted.

SECTION 7: This ordinance shall be in full force and effect from and after passage, approval, publication of the ordinance.
