TOWN OF CARLTON -----BUILDING PERMITS

WISCONSIN UNIFORM DWELLING CODE CHS 320-325 STATE STATUES

According to above no ground movement or construction shall commence without first getting a permit to construct or build any project that requires a permit from local Town Government or so appointed Zoning Administrator. Permit shall be given as it meets all local setbacks and requirements set forth by Government and Local Zoning.

If permit is not obtained prior to start, owner and contractor may and will be subject to fines/per day and removal of any work initiated without valid permit. It is property owners responsibility.

If Town is notified about invalid non permit construction, permits will be penalized 4X original cost and removal pending decision or fine/day.
