AGREEMENT

BY AND BETWEEN PIKE'S BAY SANITARY DISTRICT AND THE CITY OF BAYFIELD

REGARDING CERTAIN PARCELS IN THE PIKE'S BAY SANITARY DISTRICT CONTIGUOUS TO THE CITY OF BAYFIELD

THIS AGREEMENT is made and entered into by and between the Pike's Bay Sanitary District (the "District"), a sanitary district created pursuant to sec. 60.71, Wisconsin Statutes, P.O. Box 689, Bayfield, WI 54814, and the City of Bayfield (the "City"), a city created pursuant to Chapter 62, Wisconsin Statutes, 125 South First Street, Bayfield, WI 54814.

WHEREAS, the District and the City share common boundaries; and

WHEREAS, the District and the City executed an agreement on March 26, 2004 (the "Intermunicipal Agreement") for the joint operation, through the Greater Bayfield Wastewater Treatment Plant Commission, of a sewage treatment plant known as the Greater Bayfield Wastewater Treatment Plant (the "Plant"); and

WHEREAS, it is in the mutual interest of the parties, their residents, taxpayers, and ratepayers, to provide municipal services with the greatest possible efficiency; and

WHEREAS, the sewerage from some properties that lie within the District can most efficiently be collected and conveyed to the Plant via sewer lines owned and operated by the City, and

WHEREAS, the City already provides and will continue to supply sanitary sewer service to certain parcels that are within the District but which are contiguous to the boundaries of the City namely, 36310 North Limits Road, 36320 North Limits Road and 325 South Seventh Street and which they will be grandfathered in as City of Bayfield customers, and

NOW, THEREFORE, in consideration of the mutual promises and conditions contained below, and pursuant to sec. 66.0301, Wisconsin Statutes, the parties agree as follows:

1. City provision of services to District residents. The City may provide sewage collection services to all District parcels adjacent to and along the north side of North Limits Road, from Meyers-Olson Road to State Highway 13, and to the parcel currently owned by Celia Duquette, according to whatever arrangements are made between the City and the owners of such parcels. For all parcels within the District which are served by the City pursuant to this paragraph, all City policies regarding sewer services apply.

2. Payment for services. The City will provide the services referred to in paragraph 1 at no cost to the District. The City will meter and bill the owners of the parcels outside the corporate limits of the City for sewer services as described in the City of Bayfield Code of Ordinances ~ Sewers.

3. Application to other parcels. Upon specific written agreement, the parties may apply this agreement to parcels other than those described in paragraph 1 but which are similarly situated with regard to sewage collection services provided by the City.




