April 2024

Meetings/Training Attended

During the month of April, I attended Town Board and various other town meetings. Officer Jenks attended the Internet Crimes Against Children Conference. Officer Aldrich attended Advanced Roadside Impaired Driving Enforcement training. Sergeant Upton and I attended the DNR Boat Patrol Biannual Training in Stevens Point.

Calls for Service, Citations, and Written Warnings

In April, officers handled 102 calls for service, issued 29 citations, and 34 written warnings.

Department Activities/Announcements

The Officer that was on FMLA leave, due to a non-work-related injury, was returned to full duty in April.

I continue to work on filling open full-time vacancies, and putting the boat patrol roster together. I anticipate having a full-time officer start in mid-May, along with an additional boat patrol officer.

The regulatory buoys have been placed for the 2024 boating season. Officers will start with recreational (boating and ATV) patrols soon. Officers continue on the dead brush and timber enforcement.

I would like to inform residents it is that time of year again when the Rome Police Department starts to receive complaints on fireworks. The police department will have a zero tolerance for illegal discharge of fireworks. A commonly used rule of thumb is that if the device explodes or leaves the ground it is unlawful to discharge without a permit. The permits issued at many roadside stands indicate a specific place for the discharge of the fireworks. NONE of those are in the Town of Rome, so any discharge would be illegal and subject to a \$250.00 fine and confiscation of the fireworks.

Routine maintenance was done to the fleet in April.
