Rome Police Department Monthly Report April 2025

Meetings/Training Attended

During the month of April, I attended Town Board meetings. Officers attended training at Sand Valley to go over recent additions to the site.

Calls for Service, Citations, and Written Warnings

Officers handled 123 calls for service, and issued 25 citations and 24 written warnings.

Department Activities/Announcements

Regulatory buoys for the 2025 boating season were placed. I am in the process interviewing candidates for seasonal recreational officer positions. We have reposted due to only receiving minimal applications.

The Police and Fire Commission has provided me with a name for a full-time eligibility list.

I would like to inform residents it is that time of year again when the Rome Police Department starts to receive complaints on fireworks. The police department will have a zero tolerance for illegal discharge of fireworks. A commonly used rule of thumb is that if the device explodes or leaves the ground it is unlawful to discharge without a permit. The permits issued at many roadside stands indicate a specific place for the discharge of the fireworks. NONE of those are in the Town of Rome so any discharge would be illegal and subject to a \$250.00 fine and confiscation of the fireworks.

Routine maintenance was done to the fleet in April.
