## Rome Police Department Monthly Report December 2024

### **Meetings/Training Attended**

During the month of December, I attended Town Board meetings. Officer Aldrich and Boudreau attended operation RUSH training. Officer Jenks attended Instructor Development training.

### **Calls for Service, Citations, and Written Warnings**

Officers handled 119 calls for service, and issued 30 citations and 3 written warnings during the month.

### **Department Activities/Announcements**

The Rome Police Department ended 2024 with a total of 1,652 calls for service. In 2024 the Department issued 561 citations, that number includes traffic, municipal, and boating citations; 444 written warnings were issued throughout the year as well.

### **Vehicle Fleet/Maintenance**

Squad 84 was returned after repairs to the fuel system. Squad 85 was returned after a water pump and timing chain repairs. Routine maintenance was done to the rest of the fleet. We are still awaiting the arrival of 2025 squad cars that were ordered in the fall.
