During the month of January, I attended Town Board and staff meetings.

Calls for Service, Citations, and Written Warnings

Officers handled 121 calls for service, and issued 25 citations and 34 written warnings.

Department Activities/Announcements

The 2024 Boat Patrol claim of \$ 27,237.83 was submitted to the DNR. The DNR will audit the claim and we will receive reimbursement from the DNR of 60%-75% of the claim in early Spring.

If you are leaving town over the winter months, please stop by the police department or go to our web site and complete a vacant home form.

I would also like to remind Rome residents, that per Town Ordinance 335.10 “a snow emergency exists whenever a snowfall results in an accumulation of 3 inches or greater within a 24-hour period.” During a snow emergency, the parking of any vehicle on any portion of the roadway is prohibited. In the interest of public safety please make sure you keep the roadways clear of obstructions for our highway workers.

Routine maintenance was done to the fleet in January. A 2025 Ford Explorer was ordered to replace a 2017 Ford Explorer.
