Rome Police Department Monthly Report July 2024

Meetings/Training Attended

During the month of July, Officers attended State mandated firearms qualification training, in Adams, with the Adams Police Department. I submitted training records to DOJ for the period of July 1, 2023 thru June 30, 2024. All Officers are required to obtain 24 hours of training each year. All of our Officers satisfied the training requirements.

Calls for Service, Citations, and Written Warnings

Officers responded to 218 calls for service, issued 68 citations, and 42 written warnings. The Boat Patrol logged 131 hours of patrol, issued 16 citations and 31 warnings.

Department Activities/Announcements

The Rome Police Department will have a zero tolerance for illegal discharge of fireworks. A commonly used rule of thumb is that if the device explodes or leaves the ground it is unlawful to discharge without a permit. The permits issued at many roadside stands indicate a specific place for the discharge of the fireworks. NONE of those are in the Town of Rome, so any discharge would be illegal and subject to a \$250.00 fine and confiscation of the fireworks. If you observe illegal fireworks discharge, please report the violations by calling 1-877-885-9977.

As a reminder, State law prohibits boat and watercraft operation at a speed faster than slow no wake within 100 feet shore or 100 feet of any dock raft or pier. State law also prohibits personal watercraft from traveling faster than slow no wake within 200 feet of shore.

Lakes Camelot, Sherwood, and Arrowhead are all slow no wake after 8:00 pm. If residents observe boating violations, on a routine basis, we urge them to call the Rome Police Department so we can give these problem areas some extra attention.

Squad 84 was out of service for the replacement of both fuel pumps. The squad is back in service. Most of the equipment for the two new squads has been received and I will begin up fitting the cars when time allows. Routine maintenance was done to the remainder fleet during July.
