## Rome Police Department Monthly Report June 2024

### **Meetings/Training Attended**

During the month of June, I attended Town Board, Police and Fire Commission, and various other town meetings.

### **Calls for Service, Citations, and Written Warnings**

Officers handled 177 calls for service, issued 44 citations, and 32 written warnings. The Boat Patrol logged 103 hours of patrol, issuing 9 citations, and 17 written warnings.

### **Department Activities/Announcements**

Hunter Ebbe was rehired in June for the Boat Patrol and will help fill openings in the schedule.

I submitted the training certification for Officer mandated training to the State. We will then be reimbursed for some of our training costs by the State.

The police department will have a zero tolerance for illegal discharge of fireworks. A commonly used rule of thumb is that if the device explodes or leaves the ground it is unlawful to discharge without a permit. The permits issued at many roadside stands indicate a specific place for the discharge of the fireworks. NONE of those are in the Town of Rome, so any discharge would be illegal and subject to a \$250.00 fine and confiscation of the fireworks.

As a reminder, State law prohibits boat and watercraft operation at a speed faster than slow no wake within 100 feet of any dock, raft, pier, or the shoreline. State law also prohibits personal watercraft from traveling faster than slow no wake within 200 feet of shore. Lakes Camelot, Sherwood, and Arrowhead are all slow no wake after 8:00 pm. If residents observe boating violations, on a routine basis, we urge them to call the Rome Police Department so we can give these problem areas some extra attention.

Routine maintenance was done to the fleet in June.
