Rome Police Department Monthly Report

May 2024

Meetings/Training Attended

During the month of May, I attended Town Board and various other town meetings.

Calls for Service, Citations, and Written Warnings

Officers handled 148 calls for service, issued 43 citations, and 43 written warnings. The Boat Patrol logged 26 hours of patrol, issuing 7 citations, and 1 written warning.

Department Activities/Announcements

Officer Carter Rose started with the P.D. in May, and will complete our field training program before being assigned to solo patrol. Boat Patrol Officers have returned to service for the year.

As a reminder, State law prohibits boat and watercraft operation at a speed faster than slow no wake within 100 feet of any dock, raft, pier, or the shoreline. State law also prohibits personal watercraft from traveling faster than slow no wake within 200 feet of shore. Lakes Camelot, Sherwood, and Arrowhead are all slow no wake after 8:00 pm. If residents observe boating violations, on a routine basis, we urge them to call the Rome Police Department so we can give these problem areas some extra attention.

The police department will have a zero tolerance for illegal discharge of fireworks. A commonly used rule of thumb is that if the device explodes or leaves the ground it is unlawful to discharge without a permit. The permits issued at many roadside stands indicate a specific place for the discharge of the fireworks. NONE of those are in the Town of Rome, so any discharge would be illegal and subject to a \$250.00 fine and confiscation of the fireworks.

Routine maintenance was done to the fleet in May.
