Rome Police Department Monthly Report May 2025

Meetings/Training Attended

During the month of May, I attended Town Board a Town Board meeting. Officer Jenks attended the State Internet Crimes Against Children (ICAC) conference.

Calls for Service, Citations, and Written Warnings

Officers handled 176 calls for service, and issued 60 citations and 47 written warnings. The boat patrol logged 59 hours of patrol, issuing 3 citations during the month.

Department Activities/Announcements

I would like to inform residents it is that time of year again when the Rome Police Department starts to receive complaints on fireworks. The police department will have a zero tolerance for illegal discharge of fireworks. A commonly used rule of thumb is that if the device explodes or leaves the ground it is unlawful to discharge without a permit. The permits issued at many roadside stands indicate a specific place for the discharge of the fireworks. NONE of those are in the Town of Rome so any discharge would be illegal and subject to a \$250.00 fine and confiscation of the fireworks.

The boat patrol started the 2025 season Memorial Day weekend. The patrol will be present on the lakes throughout the summer. Please report boating violations when they are happening to the dispatch center at 608-339-3304 option 0. This will ensure an officer is dispatched to address the violation(s). Boaters please ensure you have read the current boating law pamphlet and are following it prior to hitting the water this summer. The regulations are in place to ensure everyone's safety on our lakes.

Routine maintenance was done to the fleet in May.
