Meetings/Training Attended

During the month of November, I attended Management Group, the Town Budget, Police and Fire Commission, DOJ State Crisis Intervention Program, Adams County Traffic Safety, and Town Board meetings. Officer Jenks attended a Drug Free Adams County, and Coordinated Community Response Team meetings.

Calls for Service, Citations, and Written Warnings

During the month, officers handled 113 calls for service, issued 39 citations, and 40 written warnings.

Department Activities/Announcements

Officer Warnecke competed phase one of the field training program during November. The program has four phases of training. I would anticipate the end of field training to be in early February.

I would remind residents to be aware of ice conditions on the area lakes before traveling out on the ice. We have had issues with vehicles and individuals breaking through poor ice in past years.

I am happy to report we had a safe 2025 gun deer season. No hunting accidents were reported in Town.

The police department would also like to remind those who may be leaving property, for an extended period of time, to fill out a vacant home form before leaving. The form can be picked up at the Police Department or printed from the Town web site. This helps the Police Department to be aware of properties in town that are vacant, and gives us accurate contact information for property owners in the event we would need to contact them.
