I would also like to remind Rome residents, that per Town Ordinance 335.10 “a snow emergency exists whenever a snowfall results in an accumulation of 3 inches or greater within a 24-hour period.” During a snow emergency, the parking of any vehicle on any portion of the roadway is prohibited. In the interest of public safety please make sure you keep the roadways clear of obstructions for our highway workers.
