Meetings/Training Attended

During the month of October, I attended Management Group, and Town Board meetings. I attended a von Briesen Social Media issues briefing, and a Badger TraCS virtual conference.

Calls for Service, Citations, and Written Warnings

During the month, officers handled 140 calls for service, issued 54 citations, and 31 written warnings.

Department Activities/Announcements

The Department is at full staff after hiring Officer KayLee Warnecke in October. Her first day will be November 3, 2025. She will be assigned to field training officers to complete our field training program over the next few months. I would anticipate the end of field training to be in early February.

Regulatory buoys have been removed from the lakes, and the boat patrol final report is being prepared.

The Police Department held a drug take back event on October 25, 2025 and 20.2 pounds of medication was collected since the last take back event.

The Department also participated in the Halloween event held in the Rome Town Center on October 25, 2025.

The police department would also like to remind those who may be leaving property, for an extended period of time, to fill out a vacant home form before leaving. The form can be picked up at the Police Department or printed from the Town web site. This helps the Police Department to be aware of properties in town that are vacant, and gives us accurate contact information for property owners in the event we would need to contact them.
