## Rome Police Department Monthly Report January 2026

### Meetings/Training Attended

During the month of January, I attended staff, Town Board, and Department Head meetings. Full-time staff completed CPR refresher training with the Rome Fire Department. Officer Jenks and Officer Aldrich attended Field Training Officer training.

### Calls for Service, Citations, and Written Warnings

During the month of January, officers handled 94 calls for service, issued 36 citations, and 26 written warnings.

### Department Activities/Announcements

I would encourage residents to ensure that their address signs are kept clear of obstructions. This provides for quicker response from our emergency responders. During the winter months it is easy to lose sight of the importance of these signs, allowing them to be covered or blocked by snow during snow removal. Please take the time to ensure your sign is visible from both directions.

The 2025 Boat Patrol Municipal Water Safety Patrol State Aide Application, was submitted to the Wisconsin DNR in the amount of \$ 26,786.68. Once all the claims from patrols are received and audited by the DNR, a final report with aid back to Rome will be provided. Generally, this number is between 70 and 80% of the total claim.

A 2023 Dodge charger remains out of service due to a faulty fuel pump which is not in stock. The vehicle has been out of service since mid-December. A windshield was replaced in a 2021 Ford Squad. A stone chip expanded during the below zero weather requiring a full replacement. A 2024 Ford had damage done to the rear bumper. Routine maintenance was done to the remainder of the fleet during January.
