Meetings/Training Attended

During the month of March, I attended a Town Board meeting, and Red Dot firearms training.

Calls for Service, Citations, and Written Warnings

During the month of March, officers handled 124 calls for service, issued 55 citations, and 64 written warnings.

Department Activities/Announcements

It is the time of year when recreational vehicle use increases in the Town. I would like to remind users, that they should review the legal riding areas and ensure that the units are only operated in permitted areas. Driving off trails and onto private property without permission can result in the issuance of citations, and the possibility of trail closure by land owners.

Spring wildfire season is here, burning permits are required in the Town of Rome anytime the ground is not completely snow-covered. Permit holders are authorized to burn vegetative materials, such as leaves, brush and needles. Restrictions are in place to ensure that burning is done safely with minimal wildfire risk. Permits are free and can be obtained online or by calling 1-888-WIS-BURN (947-2876).

A 2017 Ford Explorer was taken out of service and the law enforcement equipment was removed. The vehicle was sold through Wisconsin Surplus for \$3,505.00. We are in the process of installing the equipment from that vehicle into a 2026 Explorer. The new vehicle should be in service by the end of April.

Routine maintenance was done to the remainder of the fleet during the month.
