## Rome Police Department Monthly Report May 2026

### **Meetings/Training Attended**

During the month of May, I attended a Adams County Traffic Safety Committee, and staff meetings. Officers completed training in Emergency Medical Responder as required by the State of Wisconsin.

### **Calls for Service, Citations, and Written Warnings**

During the month of May, officers handled 124 calls for service, issued 57 citations, and 37 written warnings.

### **Department Activities/Announcements**

The Boating season has started, the boat patrol logged 51 hours of patrol in May, issuing one citation one written warning, and six verbal warnings. Boaters, please take the time to read the current boating law handbook prior to hitting the water this summer. Please follow all the rules to have a safe and enjoyable boating season. Here is the link to the current handbook <https://widnr.widen.net/s/0vw8hwrae3>. In addition, the Town of Rome has local regulations. Motorboat operation is restricted to Slow-No-Wake after 8pm thru sunrise. No personal watercraft shall be operated at a speed greater than slow-no-wake before 10:00 a.m. or after 8:00 p.m. Water skiing, wake surfing or being towed on other devices, shall be limited to the daylight hours between 10:00 a.m. and 8:00 p.m. or sunset whichever comes first. The regulations are in place to ensure everyone's safety on our lakes. If you see individuals violating the rules, or operating in an unsafe manner, please report it immediately by calling 877-885-9977 option 0.

The Rome Police Department will have a zero tolerance for illegal discharge of fireworks. A commonly used rule of thumb is that if the device explodes or leaves the ground it is unlawful to discharge without a permit. The permits issued at many roadside stands indicate a specific place for the discharge of the fireworks. NONE of those are in the Town of Rome so any discharge would be illegal and subject to a \$260.00 fine and confiscation of the fireworks.

It is the time of year when recreational vehicle use increases in the Town. I would like to remind users, that they should review the legal riding areas and ensure that the units are only operated in permitted areas. Driving off trails and onto private property without permission can result in the issuance of citations, and the possibility of trail closure by land owners.

Routine maintenance was done to the fleet of the fleet during the month.
