Rome Police Department Monthly Report July 2026

Meetings/Training Attended

During the month of July, I held a staff meeting/training with the Officers. Emergency Vehicle Operations Training was completed as required by State Law. Sgt. Upton attended a meeting on public safety expansions at Mid-State Technical College. Sgt. Upton attended a Town Board meeting.

Calls for Service, Citations, and Written Warnings

During the month of July, officers handled 249 calls for service, issued 58 citations, and 17 written warnings. The boat patrol logged 116 hours of patrol, issued 8 citations, and 9 written warnings.

Department Activities/Announcements

In July the Town Board enacted a wake enhancement ordinance. The use of ballast tanks/bags or fins or continuous transition operation causing bow-high operation and/or wake enhancement is now prohibited on Lakes Arrowhead, Camelot, and Sherwood.

The police department has received calls about operating faster than Slow-No-Wake and waterskiing outside allowed hours. Officers will be adding additional hours to enforce Slow-No-Wake, hours of operation, and wake enhancement violations. If you are caught violating these rules expect a citation which can be up to \$500.00 plus court costs. I have summarized the related local regulations: Motorboat operation is restricted to Slow-No-Wake after 8pm or sunset whichever comes first thru sunrise. No personal watercraft shall be operated at a speed greater than slow-no-wake before 10:00 a.m. or after 8:00 p.m. or sunset whichever comes first. Water skiing, wake surfing or being towed on other devices, shall be limited to the daylight hours between 10:00 a.m. and 8:00 p.m. or sunset whichever comes first. The regulations are in place to ensure everyone's safety on our lakes. If you see individuals violating the rules, or operating in an unsafe manner, please report it immediately by calling 877-885-9977 option 0.

The P.D. has also fielded complaints on recreational vehicle use in the Town. I would remind users, that spinning/squealing of tires on or off the road is disorderly conduct with a motor vehicle and, if caught, will result in a citation being issued. Driving off trails/roads and onto private property without permission can result in the issuance of citations, and the possibility of trail/route closure by land owners.

The police department took delivery of the 2026 Ford F150 Squad. This vehicle replaces a 2020 Dodge Charger. The setup is being completed and the vehicle will be in service next month. Routine maintenance was done to the rest of the fleet during the month.
