

ORDINANCE NO. 2

RE: Ordinance to repeal original Ordinance No. 2, dated May 24, 1949, and creating an ordinance to regulate traffic upon the streets, alleys and highways of the Township of Oakland, Jefferson County, Wisconsin.

The Board of Supervisors of the Town of Oakland, Jefferson County, Wisconsin, do ordain as follows:

Section 1. TRAFFIC REGULATIONS. The following enumerated sections of the Wisconsin Statutes, Laws of 1955, are hereby adopted by reference and made a part and portion of this ordinance for the said Township of Oakland, Jefferson County, Wisconsin:

Section 2.

(a) The Town Constable and/or the officer employed by the Township of Oakland shall place and maintain standard signs supplied by the township giving notice of the speed limitation provided above.

(b) The statutory speed limits shall not apply to authorized emergency vehicles while operating in emergencies.

Section 3. PENALTY. Any person who shall violate any of the provisions of this ordinance shall, upon conviction thereof, be punished as follows:

(a) If for violation of any provisions of this ordinance enacted by reference to any section of the Wisconsin Statutes, by forfeiting to the Town of Oakland the amount of fine designated by the proper officials in accordance with and as provided in Section 85.91 of the Wisconsin Statutes of 1955 which is hereby adopted by reference, except that the minimum taxable fine shall be one-half the minimum set forth in 85.91 and the costs of prosecution; and in default of payment of the fine and costs of

prosecution, shall be imprisoned in the Jefferson County jail, until said fine and costs are paid, but not to exceed ninety (90) days.

(b) If for a violation of the speeding provisions of this ordinance, by forfeiting to the said Township of Oakland not less than \$1.00, nor more than Fifty Dollars (\$50.00) for the first offense, and for second or each subsequent conviction within one year thereafter, by forfeiting to said township not less than Three Dollars (\$3.00), nor more than One Hundred Fifty Dollars (\$150.00), together with costs of prosecution in each instance, and in default of payment of such forfeiture and the cost of prosecution, convicted party shall be imprisoned in the Jefferson County jail for not to exceed sixty (60) days.

Section 4. All ordinances or parts of ordinances of the Town of Oakland presently in force which are in conflict with the provisions of this ordinance shall be and the same are hereby repealed.

Section 5. This ordinance shall take effect and be in force from and after its passage and publication.
