

AMENDMENT TO ORDINANCE NO. 2

Re: Ordinance regulating traffic and operation of motor vehicles in the Town of Oakland, Jefferson County, Wisconsin.

The Board of Supervisors of the Town of Oakland, Jefferson County, Wisconsin, do ordain as follows:

Section 1 of said Ordinance 2 is repealed and is created to read as follows:

Section 1. TRAFFIC REGULATIONS. Chapter 85 and Chapters 341 to 348 of the Wisconsin Statutes are hereby adopted and made a part and portion of the Traffic Regulations of the Town of Oakland, Jefferson County, Wisconsin, and such portions of said chapters which are reserved expressly by the State of Wisconsin shall have no force and effect within this ordinance.

Section 3 of Ordinance 2 is amended to read as follows:

(a) Delete from Section 3 (a) "of 1955", so said Section 3 (a) reads as follows:

(a) If for violation of any provisions of this ordinance enacted by reference to any section of the Wisconsin Statutes, by forfeiting to the Town of Oakland the amount of fine designated by the proper officials in accordance with and as provided in Section 85.91 of the Wisconsin Statutes which is hereby adopted by reference, except that the minimum taxable fine shall be one-half the minimum set forth in 85.91 and the costs of prosecution; and in default of payment of the fine and costs of prosecution, shall be imprisoned in the Jefferson County jail, until said fine and costs are paid, but not to exceed ninety (90) days.
