

ORDINANCE NO. 40

AN ORDINANCE TO RENAME AND AMEND ORDINANCE #40,
THE RECYCLING ORDINANCE FOR THE TOWN OF OAKLAND

The Town Board of the Town of Oakland, Jefferson County, Wisconsin, DO
ORDAIN as follows:

Ordinance No. 40 of the Town of Oakland shall be amended as follows:

The title of the Ordinance shall be Solid Waste and Recycling Ordinance, Town
of Oakland. Further amendments shall be as follows:

- 1.01 Title. Solid Waste and Recycling Ordinance, Town of Oakland
- 1.02 Purpose. s. 159.11, Wis. Stats. is now 287.11. In addition, the following sentence shall be added: A further purpose of this ordinance is to provide for the method of paying for the cost of recycling and/or solid waste pick-up by the township and the residents thereof.
- 1.03 Statutory Authority. 159.09(3)(b), Wis. Stats. is now 287.09(3)(b).
- 1.10 21. s. 144.01(15), Wis. Stats. is now 289.01(33).
 22. s. 144.43(5), Wis. Stats. is now 289.01(35).
- 1.12 3. s. 159.11(2m), Wis. Stats. is now 287.11(2m).
- 1.15 2. shall be repealed in its entirety and recreated to read as follows:

The Town of Oakland will not provide pick-up service for solid waste and recyclables for commercial units, including mobile home parks. The owners of such properties shall be responsible for contracting for such services with a private service provider and shall not look to the township for payment therefor.

- 1.18 Payment Procedure shall be repealed in its entirety and recreated to read as follows:

Commencing January 1, 1999, the Town of Oakland will pay the provider of services for pick-up of solid waste and recyclables directly. Owners of properties identified to receive roadside or other pick up service of solid waste and recyclables will be billed for a portion of such service by the Town of Oakland as

a special charge on their tax bill, in arrears. There will be a separate charge for each unit serviced. Multi-family units will be charged on a per family basis. For example: a duplex will be considered two units, a four-plex four units, and two single-family dwellings on same parcel will be considered two units. The first such charge will appear on the 1999 real estate tax bills, and shall be for the services provided during 1999.

Year-round units will be defined as a unit requiring more than six months of consecutive service per year. Seasonal units will be defined as a unit requiring six months or less of consecutive service per year. Vacant units will be defined as a unit where no one lives at any time during the year. New construction units will be prorated from occupancy date.

The Town Board DO FURTHER ORDAIN that this Ordinance shall become effective January 1, 1999 following its adoption and publication.
