



Resolution 2026-02

Town of Oakland

WHEREAS, the Town of Oakland currently has many of its fees and/or penalties listed within the Town of Oakland Municipal Code; a systematic compilation of the laws, rules, and regulations created by Ordinance and/or Resolution and enforced by the Town of Oakland; and

WHEREAS, the Town Board of the Town of Oakland periodically establishes or modifies various fees and/or penalties for Town of Oakland licenses, permits, activities and services; and

WHEREAS, whenever fees and/or penalties are updated or created, the Town of Oakland must pass an Ordinance or Resolution which incurs publication fees; and

WHEREAS, to save costs, Town of Oakland staff recommends removing the fee and/or penalty amounts from the Municipal Code and creating a Fee schedule that is amendable by resolution; and

WHEREAS, it is also desirable that all Town of Oakland fees and/or penalties be listed in one consolidated document; and

NOW, THEREFORE, BE IT RESOLVED, that the Town Board of the Town of Oakland, Jefferson County, Wisconsin, does hereby adopt the fees and/or penalties as listed on Exhibit A, included in this Resolution, to be effective upon posting; and

BE IT FURTHER RESOLVED, that the fees and/or penalties listed, which are incorporated herein by reference and kept on file in the office of the Town of Oakland Clerk-Treasurer, be approved, effective with the passage of this resolution; This Fee Schedule will take effect as of its posting; and

BE IT FURTHER RESOLVED that it is the intent of the Town Board of the Town of Oakland that the individual amounts listed supersede any amounts previously established by ordinance, resolution or Town Board action; and

BE IT FURTHER RESOLVED, that the said Fee Schedule will actively remain in place and be in effect until expressly updated or rescinded by majority vote by the Town Board of the Town of Oakland;

 - First occurrence ----- \$500
 - Each subsequent occurrence -----\$1,000
 - Non-Residents of the Town of Oakland depositing acceptable materials
 - First occurrence ----- \$250
 - Each subsequent occurrence -----\$500
 - Non-Residents of the Town of Oakland depositing unacceptable materials or removing materials for Town's use only
 - First occurrence ----- \$500
 - Each subsequent occurrence -----\$1,000
