ORDINANCE 41

**PROHIBITING THE SALE, POSSESSION, MANUFACTURE, AND DELIVERY OF
DRUG PARAPHERNALIA BY PERSON UNDER THE AGE OF 18**

**AN ORDINANCE REPEALING AND RECREATING SECTION 1(D)(2)
OF ORDINANCE NO. 41 OF THE MUNICIPAL CODE OF THE TOWN OF OAKLAND**

WHEREAS, the Board of Supervisors of the Town of Oakland, Jefferson County, has heretofore adopted a chapter of the Code of Ordinances relating to Court; and

WHEREAS, the Board of Supervisors of the Town of Oakland, Jefferson County, has heretofore adopted a Fee Schedule by passage of Resolution 2026-02 which is available for public inspection in the Clerk's Office of the Town of Oakland at the Town Hall; and

WHEREAS, it is the desire of the Board of Supervisors of the Town of Oakland, Jefferson County, to amend the fee schedule for services described in this chapter, and to provide for future changes by resolution rather than ordinance;

NOW, THEREFORE, the Board of Supervisors of the Town of Oakland, Jefferson County, Wisconsin, does hereby ordain as follows:

The Code of Ordinances of the Town of Oakland, Chapter 5 (Court), Ordinance 41, Section 1(D)(2), is hereby repealed in its entirety and replaced with the following:

Section 1 (D) (2) Penalties: Any person who violates sub. C(1), (2) or (3) shall, upon conviction by the Municipal Court thereof, be subject to a forfeiture as established by a Fee Schedule adopted and amended from time to time by resolution of the Town of Oakland, Jefferson County, together with costs per sec. 961.573(1), Wis. Stats. In addition, failure to pay any forfeiture imposed as a result of a violation of these provisions may result in the Municipal Court ordering imprisonment for not more than 30 days per sec. 961.573(1), Wis. Stats, and/or the suspension of that person's driver's license for not less than six (6) months nor more than five (5) years under sec. 961.50(1), Wis. Stats.

All other provisions of Ordinance No. 41 shall remain the same.

The Board of Supervisors of the Town of Oakland DO FURTHER ORDAIN that this Ordinance shall be effective upon its adoption and publication.
