COMPOST FACILITY REGULATIONS

**AN ORDINANCE REPEALING AND RECREATING SECTION 4 a, b, c and d OF
ORDINANCE NO. 2025-74 OF THE MUNICIPAL CODE OF THE TOWN OF
OAKLAND**

WHEREAS, the Board of Supervisors of the Town of Oakland, Jefferson County, has heretofore adopted a chapter of the Code of Ordinances relating to Miscellaneous; and

WHEREAS, the Board of Supervisors of the Town of Oakland, Jefferson County, has heretofore adopted a Fee Schedule by passage of Resolution 2026-02 which is available for public inspection in the Clerk's Office of the Town of Oakland at the Town Hall; and

WHEREAS, it is the desire of the Board of Supervisors of the Town of Oakland, Jefferson County, to amend the fee schedule for services described in this chapter, and to provide for future changes by resolution rather than ordinance;

NOW, THEREFORE, the Board of Supervisors of the Town of Oakland, Jefferson County, Wisconsin, does hereby ordain as follows:

The Code of Ordinances of the Town of Oakland, Chapter 25 (Miscellaneous), Ordinance 2025-74, Section 4 a, b, c and d are hereby repealed in their entirety and replaced with the following:

Section 4: The Town of Oakland Police Department is authorized to enforce the provisions of this ordinance. Any person, business or contractor violating any provision of this ordinance shall be subject to a forfeiture, which forfeiture shall be determined as follows:

- a. Residents of the Town of Oakland depositing unacceptable materials or removing materials for Town's use only shall be subject to a forfeiture as established by a Fee Schedule adopted and amended from time to time by resolution of the Town of Oakland, Jefferson County.
- b. Businesses/Contractors depositing acceptable or unacceptable materials, or removing materials for Town's use only shall be subject to a forfeiture as established by a Fee Schedule adopted and amended from time to time by resolution of the Town of Oakland, Jefferson County.

- c. Non-Residents of the Town of Oakland depositing acceptable materials shall be subject to a forfeiture as established by a Fee Schedule adopted and amended from time to time by resolution of the Town of Oakland, Jefferson County.
- d. Non-Residents of the Town of Oakland depositing unacceptable materials or removing materials for Town's use only shall be subject to a forfeiture as established by a Fee Schedule adopted and amended from time to time by resolution of the Town of Oakland, Jefferson County.

All other provisions of Ordinance No. 2025-74 shall remain the same.

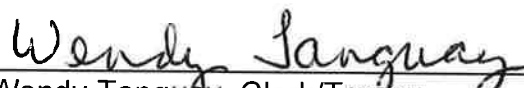
The Board of Supervisors of the Town of Oakland **DO FURTHER ORDAIN** that this Ordinance shall be effective upon its adoption and publication.
