ALUMINUM	CANS ONLY	RINSE CLEAN, FLATTENING OPTIONAL	FOIL AND BOTTLE CAPS
TIN & STEEL CANS	FOOD CANS ONLY	RINSE CLEAN FLATTENING OPTIONAL	CARDBOARD SIDES JUICE CANS, AEROSOL CANS, PAINT CANS
PLASTIC	MILK, SODA, AND DETERGENT BOTTLES MARKED #1 PETE THRU #7	RINSE CLEAN	STYROFOAM, PLASTIC CUPS, AND FIRM, HARD PLASTIC (TOYS, PAILS, ETC) MEDICINE BOTTLES & SYRINGES, PLASTIC SHOPPING BAGS (THESE CAN BE TAKEN TO PARTICIPATING RETAILERS FOR RECYCLING, i.e. WALMART, GROCERY STORES, ETC.

NEWSPAPERS, MAGAZINES, OFFICE PAPER & CARDBOARD ONLY (CARDBOARD BOXES MUST BE BROKEN DOWN)	NEWSPAPERS, MAGAZINES, CARDBOARD CARD STOCK, OFFICE PAPER, BOOKS, ENVELOPES, PAPER  OTHER EXAMPLES: BROWN PAPER TAPE, COMPUTER PRINTOUTS, FILE FOLDERS-MANILA, GLUED PADS, TABLETS, PHONE BOOKS, POST-IT NOTES & ANY JUNK MAIL	BATHROOM WASTE PAPER(TOWELS, TOILET PAPER), WRAPPING PAPER, CARBON PAPER, CELLOPHANE, CLOTH, CORK, FOIL, POLYSTYRENE STYROFOAM, ANYTHING WAXED, CANDY WRAPPERS, NAPKINS, PAPER CUPS, STYROFOAM CUPS, STYROFOAM OR PAPER FOOD CONTAINERS, PHOTOGRAPHS, FIBERBOARD, LABELS & LABEL BACKINGS

**ITEMS NOT LISTED SHALL BE CONSIDERED TRASH/GARBAGE AND DISPOSED OF IN APPROPRIATE TRASH CONTAINERS. ELECTRONICS MAY NOT BE PLACED IN TRASH OR RECYCLE DUMPSTERS.**

Construction which will require a building permit includes, but is not limited to:

1. New buildings including agricultural buildings, detached structures ( decks) and detached accessory buildings.
2. Additions that increase the physical dimensions of a building including decks.
3. Alterations to the building structure, cost shall include market labor value, or alterations to the building's heating, electrical or plumbing systems.
4. Replacement of major building equipment including furnaces and central air conditioners, water heaters and any other major piece of equipment shall require a permit except as noted in ( C ) below.
5. Alteration of plumbing, venting, electrical, or gas systems.
6. Any electrical wiring for new construction or remodeling.
7. Any HVAC for new construction or remodeling.
8. Any plumbing for new construction or remodeling.
9. Any wood burning system.

( C ) The following construction activities shall not require a building permit:

1. Re-siding, re-roofing and finishing of interior surfaces, installation of cabinetry, and repairs which are deemed minor by the Building Inspector. Notwithstanding this section, however, a permit accompanied by structural load-bearing calculations may be requested of the property owner for re-roofing a building if the proposed re-roofing would constitute a third or more layer of roofing.
2. Normal repairs of HVAC, plumbing and electrical equipment or systems such as replacing switches, receptacles and fixtures.
