Dog License Applications are **due by April 1, 2025**. (Application and fees postmarked after April 1, 2025 will be charged a **\$10.00 late fee per dog**.) In order to receive a license, please include the following items with this application:

## 1) CURRENT RABIES VACCINATION CERTIFICATE (or copy)

\*The Rabies Vaccination Certificate must include: veterinarian clinic name: vaccine manufacturer, serial number and expiration. Invoices/receipts are **not** rabies certificates and don't provide the required information to license. If you don't have a Rabies Vaccination Certificate, contact your veterinarian who can provide you with a copy.

## 2) PROOF OF BEING SPAYED OR NEUTERED

(ONLY for dogs which were not neutered/spayed in previous years or are new to the Town of Dewey)

## 3) FEES (cash or check made out to Town of Dewey)

Landlords: We rely on you to let your tenants know about dog licensing requirements.

**All dogs** over the age of 5 months **must** be licensed in the Town of Dewey, Portage County, Wisconsin, according to Wisconsin State Statute #174. *Failure to License or Vaccinate may result in a \$169 - \$263.50 citation from the Portage County Sheriff's Department.*
