

Ordinance No.14

An Ordinance to Appoint Alternate Members for the Board of Review

Section 1 – Title and Purpose

This ordinance is entitled an Ordinance to Appoint Alternate Members for the Board of Review. 1997 Wis. Act 237 has amended the procedures for the Board of Review commencing in the year 2000. The purpose of this ordinance is to establish a procedure for the appointment of alternate members for the Board of Review.

Section 2 - Statutory Authority

The Town Board of the Town of Dewey, Portage County, Wisconsin, has the specific authority under ss. 70.47(6m)(c) which authorizes the appointment of alternate members to serve on the Board of Review when standing members are removed from individual cases.

Section 3 – Adoption of Ordinance

The Town Board, by this Ordinance, adopted on proper notice with a quorum and roll call vote by a majority of the Town Board present and voting, provides the authority for the Town Board to appoint alternate members for the Board of Review for the Town of Dewey. A Public Hearing was held before the adoption of this Ordinance and notice of the hearing was given by publication of a Class 1 Notice, under Ch. 985, Wis. Stats.

Section 4 – Removal of Board of Review Members

One of the changes to s. 70.47, ss. 70.47(6m)(a) and ss. 70.47(6m)(b), Wis. Stats., authorizes the removal of Board of Review Members for individual cases.

Section 5 – Appointment of Alternate Members of the Board of Review

The Town Board of the Town of Dewey, Portage County, Wisconsin does hereby;

- (A) Adoption – Pursuant to ss. 70.47(1) and 70.47 (6m)(c) of Wis. Stats., the Town Board hereby provides for the appointment of alternates to serve on the Town of Dewey Board of Review in the event a standing board member(s) of the Board of Review is/are removed or unable to serve for any reason.
- (B) Appointments – The following electors of the Town of Dewey are hereby named alternates in the order indicated to serve as alternate Board of Review Members:
 - Alternate 1 – Josie Napiwocki
 - Alternate 2 – Rhonda Hollfelder
 - Alternate 3 – Kathy Girolamo

Section 6 – Appointment Term

The appointments made in this ordinance are for the year 2018 Board of Review proceedings and shall automatically renew each following year until Section 5 (B) of this ordinance is amended.

Section 7 – Severability

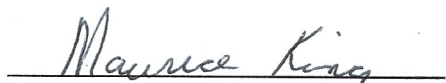

If any provisions of this ordinance or the application to any person or circumstances is held invalid, the remainder of the ordinance and the application of such provisions to other persons or circumstances shall not be deemed affected.

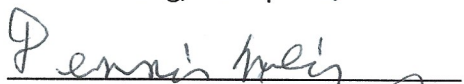
Section 8 – Effective Date

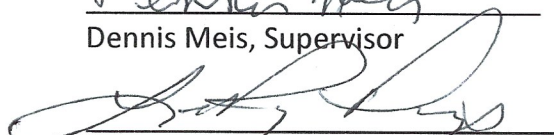
This ordinance shall become effective upon its publication and/or posting in the manner set forth in s. 60.80, Wis. Stats.

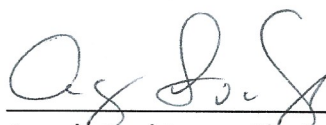
